5. The Borough Council shall have the control and management of the Athenæum, and shall maintain in connection therewith a free public library under "The Public Libraries Act, 1869."

6. The Act last named is hereby adopted within the Borough of Queenstown, and shall have the same force as if adopted by a vote of 30 the ratepayers under section five of the said Act, for all purposes of the control and management of the said library, and of levying a library rate under the said Act in support thereof, not exceeding however the limit fixed by the said Act.

7. "The Queenstown Athenaum Act, 1877," is hereby repealed. 35
