This Public Bill originated in the Legislative Council, and having this day passed as now printed is transmitted to the House of Representatives for its concurrence.

A BILL INTITULED

An Act to declare the River Districts of Waipawa and of Ashburton Title. Forks to be River Districts under "The River Boards Act, 1884."

5 WHEREAS the River Districts of Waipawa and of Ashburton Forks Preamble. were in the year one thousand eight hundred and eighty-four duly constituted river districts under the Acts then in force, but, the names of the said districts having by error been omitted from the Second Schedule of "The River Boards Act, 1884" (herein referred 10 to as "the said Act"), they are not river districts duly constituted,

although the River Boards of the said districts respectively have assumed the status, discharged duties, and done acts as if they had been duly constituted under the said Act:

For rectification thereof:

BE IT ENACTED by the General Assembly of New Zealand in 15 Parliament assembled, and by the authority of the same, as fol-

1. The Short Title of this Act is "The River Boards Act Short Title. Amendment Act, 1888."

2. The River Districts of Waipawa and of Ashburton Forks, Waipawa and 20 which were constituted river districts under "The Hawke's Bay River Act, 1876," and "The Canterbury Rivers Act, 1870," respectively. tively, are hereby declared to be constituted river districts under constituted. "The River Boards Act, 1884," and shall respectively be deemed to 25 have been duly constituted under the said Act for all purposes and in all respects as if the said river districts had been mentioned in

the Second Schedule of the said Act.

3. Every election held, valuation made, rate struck, contract validation of thing entered into, and every other act, matter, and thing of what kind or done. 30 nature soever, made, done, or suffered, or purporting to be made, done, or suffered, under "The River Boards Act, 1884," or any Act in amendment thereof, within the said river districts, or either of No. 6-2.

them, or by or on behalf of the Waipawa River Board or the Council of the County of Ashburton in its capacity as the River Board for the Ashburton Forks River District respectively, or either such Board or Council, prior to the date of the passing of this Act, shall, so far as the validity thereof depends on the facts mentioned in the preamble hereto, be and be deemed to have been as valid and effectual to all intents and purposes as if the names of the said river districts had been inserted in the Second Schedule to the said Act.

Second Schedule of Act of 1884 amended. 4. The Second Schedule of the said Act shall be read and construed as if the matter contained in the Schedule to this Act had 10 been incorporated with the said Second Schedule at the time of the passing thereof.

The said Second Schedule is hereby amended by the substitution of the figures "1602" for the figures "1567" where the latter appear in the third column thereof.
