# A BILL INTITULED

AN ACT to include in the Borough of Rotorua a Portion of the Title. Bed of Lake Rotorua, to empower the Rotorua Borough Council to reclaim such Portion, and to authorize the Vesting of Lands so reclaimed.

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows :-

1. This Act may be cited as the Rotorua Borough Reclamation short Title. 10 Empowering Act, 1931.

2. The area particularly described in the Schedule hereto is hereby Including portion declared to be included in and to form part of the Borough of Rotorua of Lake Rotorua as from the passing of this Act.

3. The Rotorua Borough Council (hereinafter referred to as the Power to reclaim.

- 15 Council) may, subject to the provisions of section one hundred and seventy-one of the Harbours Act, 1923, reclaim from the waters of Lake Rotorua the whole or any part or parts of the area described in the Schedule hereto.
- 4. (1) Upon completion to the satisfaction of the Minister of Authorizing vesting 20 Marine of the reclamation of the whole or any part of the area described of lands reclaimed. in the Schedule hereto the Governor-General may by Order in Council vest in the Corporation of the said borough, for such purpose or purposes of enjoyment or recreation as he thinks fit, any land so reclaimed.
- (2) All land vested as aforesaid shall, unless otherwise provided 25 in the Order in Council vesting the same, be held by the Corporation subject to the provisions of the Municipal Corporations Act, 1920, but leases of land subject to the last-mentioned Act may be granted under the Public Bodies' Leases Act, 1908, for the purposes of which the Rotorua Borough Council is hereby declared to be a leasing authority:

### New.

Provided that save in the case of a lease granted pursuant to the *next succeeding* subsection no lease of any such land shall authorize the erection thereon of any building other than a building necessary for the full use of such land for the purpose or purposes for which it was vested as aforsaid:

Provided further that no such building shall be erected save on a site and in conformity with a design, plans, and specifications approved by the Council on the advice of the Town-planning Board.

(3) Notwithstanding anything contained in the foregoing provisions 10 of this section, the Council may grant to the Board of Maori Arts a lease for such term at such rent and subject to such conditions as may be agreed upon between the Council and the Board of any land so vested as aforesaid adjoining land occupied by the Board.

5. The boundaries of the Borough of Rotorua as altered by this 15 Act shall be forthwith defined by notice in the *Gazette* under the hand of the Minister of Internal Affairs.

#### SCHEDULE.

#### Struck out.

ALL those portions of Lake Rotorua containing by admeasurement a total combined area of 11 acres 1 rood, situated along the lake frontage of the Borough of Rotorua in Block I, Tarawera Survey District : as the same are delineated and edged green on the plan numbered 6821, deposited in the office of the Marine Department, Wellington, and the boundaries of which are as follow :---

(a) Commencing on the shore of Lake Rotorua at the north-eastern corner of Tahererauti No. 2 Block, Ohinemutu Pa; thence north-easterly in continuation of the south-eastern boundary of the said block, a distance of 113.44 links, bearing  $46^{\circ}$  1' 40''; thence south-easterly in a straight line towards the north-eastern corner of the Marine Parade, a distance of 1120 links, bearing  $120^{\circ}$  16', to the western side of the wharf approach; thence generally south-westerly along the said western side of the wharf approach to the lake-shore; thence generally north-westerly along the lake-shore to the commencing-point: containing an area of 4 acres.

(b) Commencing on the lake-shore at the north-eastern corner of the Marine Parade; thence generally south-westerly and westerly along the lake shore to the eastern side of a road; thence north-easterly along the eastern side of the said road and of the wharf approach to a point in continuation of the north-eastern boundary of the portion (a) hereinbefore described; thence south-easterly a distance of 1536 links, bearing 120° 16', to the commencing point: containing an area of 7 acres 1 rood. Be the aforesaid dimensions a little more or less.

#### New.

ALL those portions of Lake Rotorua containing by admeasurement a total combined area of 12 acres 0 roods 37 perches, situated along the lake frontage of the Borough of Rotorua in Block I, Tarawera Survey District: as the same are delineated and edged red on the plan numbered 6821, deposited in the office of the Marine Department, Wellington, and the boundaries of which are as follow:—

(a) Commencing on the shore of Lake Rotorua at the north-eastern corner of Tahererauti No. 2 Block, Ohinemutu Pa; thence north-easterly in continuation of the south-eastern boundary of the said block, a distance of 71.44 links, bearing  $46^{\circ}$  1' 40''; thence south-easterly a distance of 1030.07 links, bearing  $115^{\circ}$  49' 30'', to the western side of a new wharf-approach road; thence south-westerly along the western side of the said road, a distance of 500.18 links, bearing  $210^{\circ}$  53', to the lake-shore; thence generally north-westerly along the lake-shore to the commencing-point; containing an area of 3 acres 1 rood 3 perches.

Boundaries of borough to be redefined.

(b) Commencing at a point where the lake-shore and the eastern side of the abovementioned new wharf-approach road intersect; thence north-easterly along the eastern side of the said road, a distance of  $541\cdot09$  links, bearing  $30^{\circ}$  53', to a point distant  $100\cdot39$  links, bearing  $115^{\circ}$  49' 30'', from the easternmost corner of the portion (a) hereinbefore described; thence south-easterly a distance of  $1469\cdot08$  links, bearing  $115^{\circ}$  49' 30'', to a point on the present water-line of the lake; thence southerly a distance of  $215\cdot0$  links, bearing  $180^{\circ}$  1' 42'', to the original lake-shore at the boundary of the Municipal Reserve; thence generally westerly and north-westerly along the lake-shore to the commencing-point: containing an area of 8 acres 3 roods 34 perches. Be the aforesaid dimensions a little more or less.
