BE IT ENACTED by the General Assembly of New Zealand in 5 Parliament assembled, and by the authority of the same, as follows:—

1. The Short Title of this Act is "The Religious, Charitable, Short Title.

(2.) Where any Bishop or Archbishop is succeeded in the same diocese by another Archbishop or Bishop, such last-mentioned Archbishop or Bishop, as the case may be, shall be deemed to be the same corporation sole as his predecessor or predecessors in the said diocese.
