BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows :---

251. This Act may be cited as the Riverton Harbour Loan and Short Title. Empowering Act, 1911.

2. It shall be lawful for the Riverton Borough Council from Power to borrow. time to time as it may require to borrow the sum of seven thousand pounds for the purpose of constructing harbour-works within the

30 Harbour or Port of Riverton.

3. The said Council may pledge any property vested in it security for the under the Riverton Corporation Empowering Act, 1889, as aforesaid loan. as security for the said loan, but shall not pledge the same for any loan which may at any time be raised by the Council for other than **8**5 harbour purposes.

4. This Act shall be deemed to be a special Act within the special Act. meaning of the Harbours Act, 1908.
