## A BILL INTITULED

An Act to further amend "The Rabbit Nuisance Act, 1882." BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as fol-5 lows:-

1. The Short Title of this Act is "The Rabbit Nuisance Act Short Title. Amendment Act, 1899," and it shall form part of and be read together with "The Rabbit Nuisance Act, 1882," herein called "the principal Act."
