A BILL INTITULED

**An Act to remove the Radio Company Limited from the State-Owned Enterprises Act 1986 and other legislation**

BE IT ENACTED by the Parliament of New Zealand as follows:

- 5     **1. Short Title and commencement**—(1) This Act may be cited as the Radio New Zealand Act (No. 2) **1995**.  
      (2) This Act shall come into force on a date to be appointed by the Governor-General by Order in Council.
