BE IT ENACTED by the General Assembly of New Zealand

(3) On the hearing of any such application the Magistrate shall proceed in the same manner in all respects as if the application were an application made under section four of the Rent Restriction Act.

(5) Paragraph (s) of subsection one of section sixty-six of the Hawke's Bay Earthquake Act, 1931, is hereby repealed.
