### A BILL INTITULED

AN ACT to vest certain Lands in the District of Title.  
 Roxburgh in Trustees, for the recreation of the  
 Inhabitants of the Town of Roxburgh and sur-  
 rounding District.

**W**HEREAS by a grant from the Crown, dated the thirtieth day of Preamble.  
 October, one thousand eight hundred and seventy-two, the lands  
 described in the Schedule to this Act were granted to James Macan-  
 drew, as and being Superintendent of the Province of Otago, in trust  
 5 for recreation purposes for the inhabitants of the Town of Roxburgh  
 and surrounding district: And whereas it is expedient to provide for  
 the management of the said land:

BE IT THEREFORE ENACTED by the General Assembly of New  
 Zealand in Parliament assembled, and by the authority of the same,  
 10 as follows:—

1. The Short Title of this Act shall be "The Roxburgh Recreation Short Title.  
 Reserve Act, 1877."

2. The land described in the Schedule hereto shall be and is Lands vested in Trust.  
 hereby transferred to and vested in the Mayor of the incorporated  
 15 Town of Roxburgh for the time being by virtue of his office, George  
 Mackay, John Beighton, James Woodhouse, Patrick Ormond, Edward  
 Moses Manuel, all of the District of Roxburgh, settlers, under the  
 name of "The Roxburgh Recreation Reserve Trust;" and such Trust  
 shall be a Corporation, and have all the powers and privileges of cor-  
 20 porations.

3. The said Trust may manage the said land described in the The Trust may manage lands.  
 Schedule hereto, as to the same Trust seems meet, but so that the  
 said land shall be used for recreation purposes only for the inhabitants  
 of Roxburgh and surrounding districts.

4. The Governor may, on the petition of the majority of the Trust may be dissolved.  
 25 members for the time being of the said Trust, dissolve the said Trust,  
 and on such dissolution the said lands shall vest in the Corporation of  
 the incorporated Town of Roxburgh, in trust for recreation purposes.

5. If any members of the said Trust shall resign, or shall be absent for twelve months from the Otago Provincial District, or shall be adjudicated a bankrupt or insolvent, or take the benefit of any Act for the relief of debtors, or shall be convicted of any felony, he shall cease to be a member of the said Trust, and the Governor may, in case of such vacancy, or in the case of the death of any member, appoint another or others in his place. 5

#### SCHEDULE.

ALL that parcel of land situate in the Teviot District, being Section numbered thirty-three (33), Block two (II.), on the map of the said district, containing by admeasurement three hundred (300) acres, more or less. Bounded towards the North by Crown lands and the Town of Roxburgh four thousand nine hundred (4900) links; towards the East by the Clutha River nine thousand one hundred (9100) links; towards the South by Crown lands one thousand (1000) links, and by part of Section numbered thirty-one (31), Block two (II.), Teviot District, six hundred and ninety-six (696) links: and towards the West by a road line one thousand two hundred and thirty (1230) links, also by Crown lands six thousand nine hundred and sixty (6960) links, and intersected by a road line one hundred (100) links wide, also by two (2) water-races.
