A BILL INTITULED

An Act in Amendment of "The Sheep Act, 1878," and in Pre-Title. vention of the Recurrence of Infection with Scab.

BE IT ENACTED by the General Assembly of New Zealand in 5 Parliament assembled, and by the authority of the same, as follows:—

1. The Short Title of this Act is "The Sheep Acts Amendment Short Title. Act, 1887." It shall be read and construed together with "The

Sheep Act, 1878" (herein referred to as "the said Act").

2. From and after the passing of this Act, the said Act, and Inspectors and 10 "The Sheep Act 1878 Amendment Act, 1886," shall be read as if the words "Chief Inspector" and "Inspector" or "Inspectors" had been omitted therefrom, and as if the words "Inspector" and "Sub-Inspector" or "Sub-Inspectors" had been respectively substituted in their place wherever such first-mentioned words occur therein.

But this provision shall not apply to the word "Inspector" where it appears between inverted commas in section five of the said Act.

3. Section forty-five of the said Act is hereby amended by the Amendment of omission therefrom of the word "negligently" in the several places section 45 of principal Act. where the said word occurs therein.

4. Upon such report as aforesaid the Governor may direct the Commissioner of Crown Lands of the district wherein the run is situate forthwith to issue a notice in the Gazette revoking the license issued in respect of the said run, and such license shall be thereupon 10 absolutely revoked, and no new license shall be issued in respect of such run until such time as the Colonial Secretary shall be advised that sheep may be permitted to depasture thereon without fear of infection.

No licensee of any run shall be entitled to any compensation by 15 the reason of the revocation of his license under the authority of this section.

Compensation moneys to be deemed part of cost of administration of Act. 6. All sums to be paid as compensation in respect of any sheep destroyed under the authority of this Act may be paid out of any moneys from time to time appropriated for the purposes of the 20 administration of the said Act.
