## A BILL INTITULED

An Act to authorise the Manukau City Council, the Mount Wellington Borough Council, the Otahuhu Borough Council, and the Papatoetoe City Council to establish and lease 5 bus depots and to borrow money for the acquisition and establishment thereof

WHEREAS it is desirable and expedient that the Manukau City Council, the Mount Wellington Borough Council, the Otahuhu Borough Council, and the Papatoetoe City Council 10 be authorised to establish bus depots and to lease the same to passenger transport service operators and to borrow money for the acquisition and establishment of bus depots: And whereas doubts have arisen whether the said Councils have power to do so at present:

15 BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. Short Title—This Act may be cited as the South Auckland Local Authorities Empowering Act 1966.

2. Interpretation—In this Act, unless the context otherwise requires,—

"Bus depot" includes premises where passenger transport service vehicles may be garaged, serviced, repaired, and overhauled and staff and administration facilities and offices for passenger transport services;

"Councils" means the Manukau City Council, the Mount Wellington Borough Council, the Otahuhu Borough Council, and the Papatoetoe City Council; and where necessary includes the corporations of the cities of 10 Manukau and Papatoetoe and of the boroughs of Mount Wellington and Otahuhu.

- 3. Authority to establish bus depots—The Councils may from time to time establish bus depots and for that purpose may purchase or lease upon and subject to such terms and 15 conditions as they think fit any area or areas of land or buildings and may erect such buildings and carry out and execute such works and provide such facilities as they think fit
- 4. Authority to lease bus depots—Notwithstanding any-20 thing contained in any Act the Councils may lease any bus depots established under the authority contained in this Act to any passenger transport service operator or operators upon and subject to such terms and conditions as they think fit; and may accept surrenders, grant renewals, and consent to 25 assignments of any such lease as they think fit.
- 5. Authority to borrow money—Subject to the provisions of the Local Authorities Loans Act 1956, the Councils may from time to time borrow money for the acquisition, establishment, erection, maintenance and improvement of bus 30 depots as they think fit.
- 6. Costs of promoting Act—The costs of promoting this Act, and of all matters preparatory and incidental thereto, shall be paid out of the District Funds of the cities of Manukau and Papatoetoe and the boroughs of Mount Wellington and 35 Otahuhu.
