A BILL INTITULED

AN ACT to vest Part of the Foreshore within Sumner Estuary, opposite Title. Shag Rock, between Christchurch Tramway Causeway and the Christchurch-Sumner Road, in the Corporation of the Borough of Sumner.

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:--

- 1. This Act may be cited as the Sumner Borough Land Vesting Act, Short Title.
- 2. This Act shall be deemed to be a special Act within the meaning Deemed a special of the Harbours Act, 1923.

3. On the passing of this Act the land described in the First Schedule hereto shall vest in and be the property of the Corporation of the Borough of Sumner for the purposes of a public road, and the land described in the Second Schedule hereto shall vest in and be the property of the Corporation of the Borough of Sumner as a reserve for the use, recreation, and enjoyment of the inhabitants of the Borough of Sumner.

3A. On the passing of this Act the lands described in the Schedule vesting lands in hereto shall vest in and be the property of the Borough of Sumner for Corporation. such public purpose or purposes for which the Sumner Borough Council may consider it necessary or advisable to use the said lands or any part thereof in the interests of the inhabitants of the Borough of $\mathbf{Sumner}:$

Provided that in respect of any work proposed to be constructed in or upon the said lands below high-water mark of ordinary spring tides the approval of the Governor-General in Council to such work shall be obtained, in the manner provided by the Harbours Act, 1923, before any such work is commenced.
