A BILL INTITULED

An Acr to regulate the Election of School Committees.

WHEREAS it is expedient to make other provision in the matter of the election Preamble. of School Committees:

BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:-

- 1. The Short Title of this Act is "The School Committees Election Act, Short Title. 1883."

prescribed by section four of the said Act, the names of those members of each Committee within the district who retire from office, and the times and places appointed for the annual meetings of householders by section six of this Act required to be held, and shall call upon the householders entitled to vote to send to the Chairmen of the respective School Committees written nominations of persons qualified in accordance with the provisions of this Act and of section fifty-eight of the said Act to be elected members of the School Committee; and all or any of the retiring members of any Committee shall be eligible for re-election. Such nominations shall be signed by the proposer and by the candidate, and shall be in the form of the Schedule to this Act or to 10 the general effect thereof, and shall be sent to the Chairman of the School Committee, so that he may receive the same not later than the fifteenth day of the month of April.

5. So soon as possible after the said fifteenth day of April such Chairman shall cause a list of the nominations to be displayed conspicuously on the outer 15 door of the main entrance of every schoolhouse within the school district, and of any courthouse or post office within such district.

6. On the thirtieth day of the month of April, or if that date fall upon a Sunday or Saturday, then on the Friday next preceding, a public meeting of the householders in every school district shall be held at the time and place 20 appointed by the Board, as in section four of this Act provided. meeting a Chairman shall be chosen, and the Committee for the preceding year shall give a full report of its proceedings, and present a duly-audited balancesheet of its accounts up to the thirty-first day of March next preceding the date of such meeting, and thereupon the election of as many members of Committee 25 as are required to fill the places of those retiring from office shall be proceeded

If the required number of persons, and no more, shall have been nominated as hereinbefore provided, the Chairman shall declare such persons to be duly

If less than the required number of persons shall have been so nominated, the persons nominated shall be declared duly elected as members of the Committee, and the vacant seat or seats shall be filled up by the Committee at their first meeting under the powers conferred by this section and section eight of this Act.

If more than the required number of persons shall have been nominated, a ballot shall be taken, and the three, or four, persons, as the case may be, who shall receive the largest number of votes shall be duly elected.

Provided always that no elector may exercise a larger number of votes than there are persons to be elected, nor record more than one vote for any one 40 candidate.

7. In the case of a tie between any two or more candidates, the Chairman shall have a casting vote, or may decide such tie by lot.

8. If any vacancy shall occur in any Committee by death, resignation, or otherwise than by effluxion of time, the remaining members of the Committee 45 shall elect a qualified person to fill such vacancy, and the person so appointed shall hold office until the date at which the member whose seat he has been elected to fill would by effluxion of time have vacated office.

9. If a member of a School Committee be absent during three consecutive months from all meetings of the Committee, except from temporary illness or 50 other cause to be approved by the Committee, such person shall cease to be a member of the Committee, and his or her office shall thereupon be vacant.

10. If by any means the number of members of a School Committee be Special elections. reduced to less than the number required for a quorum, or if five or more members of any Committee shall signify to the Education Board their desire to be relieved from office, the Board may declare their seats vacant, and may direct 5 an election to be held to fill up the vacancies; and the proceedings in connection with such election shall be the same as in the case of an annual election.

11. If after any such special election as in the last preceding clause pro- Priority of retirevided for any question shall arise as to which of the members so elected shall retire at the next succeeding annual election, such question shall be decided by 10 the Committee by ballot, and the result notified to the Board, as provided in section three of this Act.

12. If any dispute shall arise respecting the validity of the proceedings at Settlement of disthe annual or other election of a member or members of any Committee, the matter in dispute shall be submitted to the judgment of the Board of the district, ings. 15 whose decision therein shall be final and conclusive.

13. If in any case the householders in any school district shall, from any cause whatever, fail to carry out any annual or other election at the date appointed for the same, it shall be lawful for the Board, if it shall see fit, to fix another day for such election, and the same notice shall be given and, as nearly as may 20 be, the same proceedings taken thereat as are prescribed in sections four to seven, inclusive, of this Act.

14. If at such last-mentioned meeting the householders neglect or refuse In case of neglect to elect a Committee, or, without such meeting having been held, the Board may, or rerusal, Comm if it shall see fit, appoint a Commissioner for the purposes hereinafter mentioned.

15. The Commissioner so appointed shall exercise all powers and duties by Duties of Commisthe said Act or this Act imposed and conferred on Committees of school districts at any time after he shall have assumed the place and duties of the Committee as aforesaid; and a salary to be paid to the Commissioner shall be fixed by the Board, if it shall see fit, and shall be paid out of any moneys available for dis-30 tribution in the school district for or to which such Commissioner is appointed.

But such Commissioner shall only hold office from the date of appointment to the thirtieth day of the month of April next ensuing, and he shall be guided in the performance of his duties by instructions to be given him by the Board from time to time.

The power to appoint a Commissioner shall include a power to appoint more than one Commissioner, if the Board see fit, and the foregoing provision shall take effect accordingly.

16. Sections three to six of this Act shall not apply to a first election of a First elections of Committee for a new school district established in pursuance of sections sixty 40 and sixty-one of the said Act, nor to an annual election held in a district in and for which a Commissioner or Commissioners shall have been appointed, in pursuance of sections fourteen and fifteen of this Act; but in either of such cases the number of members of Committee to be elected shall be seven, and the sending in of nominations prior to the date of election shall not be required: 45 Provided always that, if in either of such cases more candidates than seven be proposed, the election shall be conducted by ballot, and that no householder shall be entitled to poll more than one vote for any one candidate.
