A BILL INTITULED

An Act to amend "The Supreme Court Judges Act, Title. 1858."

WHEREAS by "The Supreme Court Judges Act, 1858," (here-preamble after referred to as "the said Act,") it is enacted that every Judge of the Supreme Court, holding office during good behaviour, who shall resign his office after having attained the age of sixty years, 5 shall, after the passing of the said Act, be entitled to a superannuation allowance in proportion to the amount of his annual salary at the time of resignation, after the following rate, namely,-

After ten years' service, to an annual allowance of three-

twelfths of such salary:

After fifteen years' service, to an annual allowance of fourtwelfths of such salary:

After twenty years' service, to an annual allowance of fivetwelfths of such salary:

After twenty-five years' service, to an annual allowance of sixtwelfths of such salary:

After thirty years' service, to an annual allowance of seventwelfths of such salary:

After thirty-five years' service, to an annual allowance of eighttwelfths of such salary:

20 And whereas it is expedient that the rate of such superannuation allowance should in such cases as hereafter provided be increased:

BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. The Short Title of this Act shall be "The Supreme Court Short Title.

2. Every Judge of the Supreme Court, holding office during good Superannuation behaviour, who having served, whether continuously or not, fifteen allowance of Judgo over sixty years of years and less than twenty-five years as Judge of the Supreme Court, age, resigning after fifteen and less than twenty-five years as shall resign his office after having attained the age of sixty years, shall, after the passing of this Act, be entitled to a superannuation service, to be one-allowance of one-half of the amount of his annual salary at the time of resignation.
