A BILL INTITULED

An Act to amend the State-Owned Enterprises Act 1986

BE IT ENACTED by the Parliament of New Zealand as follows:

- 5 **1. Short Title and commencement**—(1) This Act may be cited as the State-Owned Enterprises Amendment Act 1987, and shall be read together with and deemed part of the State-Owned Enterprises Act 1986* (in this Act referred to as the principal Act).
