A BILL INTITULED

AN ACT to amend the Small Farms (Relief of Title. Unemployment) Act, 1932–33.

BE IT ENACTED by the General Assembly of New 5 Zealand in Parliament assembled, and by the authority

of the same, as follows:-

1. This Act may be cited as the Small Farms (Relief short Title. of Unemployment) Amendment Act, 1935, and shall be read together with and deemed part of the Small

10 Farms (Relief of Unemployment) Act, 1932–33 (hereinafter referred to as the principal Act).

2. (1) For the purposes of the principal Act "the Interpretation. Minister" means the Minister of Lands.

(2) The last preceding subsection is in substitution Consequential 15 for section three of the principal Act, and that section repeal.

is hereby accordingly repealed.

(3) For the purposes of this Act,-

"The Board "means the Board established under the principal Act: The expression "Crown land subject to the principal Act" shall be deemed to include—

(a) All land of which the fee-simple has been acquired by the Crown under the principal Act or under Part I of the Unem- 5 ployment Amendment Act, 1932, whether before or after the passing of this Act, and whether by way of purchase or by way of gift or otherwise:

(b) All land of the Crown resumed under 10 the principal Act, whether before or after the passing of this Act:

(c) All land of the Crown set aside for the purposes of the principal Act, whether before or after the passing of this Act.

3. With the consent of the Board, the Minister may, by writing under his hand, declare any Crown land subject to the principal Act to be ordinary Crown land available for disposal under the Land Act, 1924.

4. (1) Where any Crown land subject to the 20 principal Act comprises the whole of the land for which any instrument of title has been issued under the Land Transfer Act, 1915, the instrument of title shall be cancelled.

(2) Where any such land comprises part of the land 25 for which any instrument of title has been issued, the instrument of title shall be cancelled so far as it relates to that part of the land. The District Land Registrar shall retain the partially cancelled instrument, and when required by the person entitled thereto shall issue 30 to that person, without payment of any fee, a certificate of title for the balance of the land for which the partially cancelled instrument was issued.

5. (1) Leases of any Crown land subject to the principal Act may be granted under section eight of 35 that Act.

(2) No fee shall be payable on the registration of any such lease.

6. (1) On the expiration of any lease granted under section eight of the principal Act the lessee shall have 40 a right, at his option, to purchase the land comprised in the lease for cash or on deferred payments, or to select the land on renewable lease. Subject to the

(2) The price at which the land may be purchased for cash or on deferred payments shall be determined 10 in the manner provided by section thirteen of the

- principal Act. (3) For the purposes of this section—
 - (a) The term of a renewable lease and of the successive renewals thereof shall be thirtythree years:
 - (b) The rental payable under a renewable lease and under the successive renewals thereof shall be determined in the manner provided by section eleven of the principal Act:
- (c) The capital value of the land comprised in a renewable lease or in any renewal thereof shall be the amount that would be fixed under section thirteen of the principal Act as the price for the acquisition of the fee-simple of the land if the lease or renewal were a lease

under section eight of that Act. (4) Nothing in this section shall be construed to restrict the right of purchase conferred on lessees by subsection three of section eight of the principal Act.

- 30 7. (1) Section six of the Small Farms (Relief of Power to make Amendment Act, 1933, is hereby advances to Unemployment) extended so as to authorize the Board to make advances or re-advances pursuant to that section to any lessee of land administered by a Land Board under the Education
- 35 Reserves Act, 1928, who for the time being is, or, if he did not hold his lease, would be, qualified to receive a lease under section eight of the principal Act.

(2) This section shall be deemed to have come into force on the twenty-second day of December, 40 nineteen hundred and thirty-three (being the date of the passing of the Small Farms (Relief of Unemployment) Amendment Act, 1933).

8. (1) For the purpose of making any unoccupied land that is administered by a Land Board under the Education Reserves Act, 1928, available for occupation the Board may, with the consent of the Minister of Education, cause to be undertaken and carried out in $\mathbf{5}$ connection therewith such works as it thinks fit, or cause the land to be subdivided or prepared for occupation, and thereafter the Land Board, in pursuance of its powers in that behalf as modified by this section, may, at the request of the Board, grant leases of the 10 land or of any part thereof, without competition, to persons, to be selected by the Board, who are for the time being qualified to receive leases under section eight of the principal Act.

(2) Before a lease of any land is granted pursuant 15 to this section the Board shall determine the amount of the expenditure incurred by it in respect of that The amount so determined shall be notified land. to the intending lessee, and, upon the granting of the lease, shall be deemed to have been advanced to the 20 lessee by the Board under section six of the Small Farms (Relief of Unemployment) Amendment Act, 1933, as extended by the *last preceding* section, and shall be secured and repayable accordingly.

9. (1) Any rent payable under a lease granted 25 under or in accordance with the principal Act or this Act or Part I of the Unemployment Amendment Act, 1932, and any interest payable under a mortgage or other instrument securing advances made under or in accordance with any of those Acts may, in case of 30 default by the lessee, mortgagor, or other person liable to pay the same, be paid out of the Unemployment Fund in accordance with the provisions of subsection two of section five of the Unemployment Act, 1930.

(2) This section shall apply with respect to any 35rent or interest payable at any time, whether before or after the passing of this Act, since the thirtieth day of April, nineteen hundred and thirty-two (being the date of the passing of the Unemployment Amendment Act, 1932). 40
