# SUBORDINATE LEGISLATION (CONFIRMATION AND VALIDATION) BILL (NO. 2)

#### **EXPLANATORY NOTE**

THIS Bill confirms and validates certain subordinate legislation made under enactments providing that the legislation lapses after a time unless confirmed or validated by Act of Parliament.

Clause 1 relates to the Bill's Short Title. Clause 7 (2) is deemed to have come into force on 30 December 1995. The rest of the Bill comes into force on the day on which it receives the Royal assent.

Clause 2 provides that the Bill binds the Crown.

Clause 3 validates and confirms an order under the War Pensions Act 1954.

Clause 4 validates and confirms orders under the Social Security Act 1964.

Clause 5 confirms orders under the Customs Act 1966.

Clause 6 confirms an order under the Road User Charges Act 1977.

Clause 7 relates to orders under the Tariff Act 1988.

Subclause (1) validates and confirms orders that are still in force.

Subclause (2) retroactively validates and confirms the Tariff (Miscellaneous) Amendment Order (No. 3) 1994, which lapsed at the end of 1995 because it had not been validated and confirmed before then. That order in fact reduced rates of duty, so reviving it confers benefits on people who would otherwise have to pay more.

Clause 8 confirms orders under the Commodity Levies Act 1990.

Clause 9 repeals earlier enactments, now spent, confirming and validating subordinate legislation.

Clause 10 revokes certain regulations, now superseded, made under the Agriculture (Emergency Powers) Act 1934. It would have been possible for the
