## A BILL INTITULED.

An Act for establishing the Principle of the Profits derived from Tible. State Enterprises being distributed as a State Profits-sharing Scheme amongst the Workers of the Dominion instead of using those Profits to relieve Capitalists of Taxation.

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows :-

1. This Act may be cited as the Sharing of Profits of State Short Title.

### SCHEDULE.

Pensions to the aged at 55 years, £1 per week.

Allowances to the incapacitated, £1 weekly; if married, an additional 10s. weekly for wife and 5s. weekly for each child under 17 years.

Pensions of £1 weekly to widows, and 5s. weekly for each child under 17 years. Allowances of 5s. weekly for each child of worker taking secondary education course.

Allowances of £1 weekly for each child of worker over 17 and up to the age of 22 taking University course.

Bonus of £20 for each child of worker born in family where worker's earnings do not exceed £160 yearly; bonus of £10 for each child of worker whose earnings do not exceed £250 yearly.

Workers whose earnings do not exceed £160 per annum to be given a yearly allowance of £20 for each child above the number of two; and for workers whose earnings do not exceed £250 per annum a yearly allowance of £20 for each child above the number of three; in each case the allowance to continue until the child is 17 years of age.

Assistance in Times of Sickness.—Free medical attention, free medical comforts, drugs, medicines, dressings, free places in hospitals or nursing or maternity homes for all workers whose yearly earnings do not exceed £200; and free medical attention, free medicines and drugs, dressings, and general medical comforts for workers whose earnings do not exceed £300 per annum and are over £200 per annum.
