A BILL INTITULED

AN ACT for promoting the Revision of the Statute Law by repealing Enactments which have ceased to be in Force or have become unnecessary. Title.

5 WHEREAS it is expedient that certain enactments which may be regarded as spent, or have ceased to be in force otherwise than by express specific repeal by Parliament, or have by lapse of time or otherwise become unnecessary, should be expressly and specifically repealed: Preamble.

10 BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:—

1. The Short Title of this Act is "The Statutes Repeal Act, 1902." Short Title.

15 2. The enactments and parts of enactments described in the Schedule hereto are hereby repealed. Repeals.

3. Where any enactment not comprised in the Schedule hereto has been repealed, confirmed, revived, or perpetuated by any enactment hereby repealed, such repeal, confirmation, revivor, or perpetuation shall not be affected by the repeal effected by this Act. Acts not in Schedule not affected by repeal.

20 4. This Act shall not be deemed to revive or restore any jurisdiction, duty, office, drawback, fee, payment, custom, right, title, privilege, claim, restriction, exemption, procedure, or other matter or thing not now existing or in force. This Act not to affect any matter or thing not now existing.
