A BILL INTITULED

AN ACT to confer Additional Powers upon the South Rakaia Domain Title. Board.

BE IT ENACTED by the General Assembly of New Zealand in 5 Parliament assembled, and by the authority of the same, as follows :----

1. The Short Title of this Act is "The South Rakaia Domain Short Title. Board Empowering Act, 1885."

2. The South Rakaia Domain Board may, by resolution from South Rakaia time to time to be passed, which resolution shall be advertised in Domain Board may fix not more than

may be imposed prior to his obtaining admission to such stand: Provided that not more than ten shillings shall be charged for admission to such stand during any one day.

3. The Board may, by resolution, at any time authorize any person, body, or society (incorporate or not) to erect upon some 5 portion of the said reserve a stand or pavilion, upon such terms as to plans, size, situation, mode and price of admission thereto, custody, and otherwise in all respects as the Board shall, by such resolution, determine.

4. Any person who shall enter the said reserve or stand upon 10 any such day so fixed without having paid such fee or charge, according to the said resolution, shall be liable to a penalty of not more than twenty shillings.

5. This Act shall continue in operation until the first day of January, one thousand eight hundred and ninety-five, and no longer. 15

FIRST SCHEDULE.

ALL that piece or parcel of land, containing by admeasurement 50 acres, more or less, being Suburban Sections numbered 21, 22, 23, 24, 25, 26, 27, 28, 29, and 30 of Block V. on the plan of the suburban lots, Town of South Rakaia.

SECOND SCHEDULE.

Any Sunday, New Year's Day, Good Friday, the Queen's Birthday, the Prince of Wales's Birthday, Christmas Day, and the sixteenth day of December in any year.
