"31B Panel to request or approve inspection

15 "(1) The Registrar, or any person authorised by the Registrar, must not do any of the things listed in section 31A(1)(a) to (c) without the request or approval of the Panel.

- A request or approval of the Panel under subsection (1)—
 - "(a) must be made for the purposes of Part III; and
 - "(b) may relate to a particular case or limited class or classes of cases specified by the Panel.
- In determining whether to make a request or approval under subsection (1), the Panel must consider, along with any other relevant matters, any matters relating to the necessity or expediency of carrying out an inspection, for example, whether it is practicable to obtain the information from other sources or by other means in the time available.
- The fact that the Registrar, or any person authorised by the Registrar for the purposes of section 31A, requires the produc-30 tion of a document, or makes or attempts to make an inspection, is sufficient evidence that subsection (1) has been complied with, unless there is evidence to the contrary.

The Court must determine the appeal by either dismissing the appeal or giving such directions or making such determination in the matter as it thinks fit.

"31K Requirements where appeal allowed

To the extent that an appeal in respect of an act or decision of the Registrar, or any person authorised by the Registrar, under any of sections 31A to 31C is allowed or granted—

"(a) the Registrar must ensure that, as soon as practicable after the decision on the appeal is given, all records made by the Registrar, or by a person authorised by the Registrar, under **section 31A(1)(c)** in respect of the act or decision are destroyed; and

"(b) no information acquired under paragraph (a) or paragraph (b) of section 31A(1) in respect of the act or decision is admissible in evidence in any proceedings.
