WHEREAS the lands described in the Schedule hereto, together Preamble. with the said buildings, fixtures, and improvements thereon, have, since the said Board was constituted, been used and occupied by the

- 10 said Board for the reception and relief of aged, infirm, incurable, and destitute persons, and for other purposes authorised by "The Hospital and Charitable Institutions Act, 1885," but the said Board has not obtained any title thereto, the fee-simple being vested in Her Majesty the Queen: And whereas it is expedient that the said lands,
- 15 buildings, fixtures, and improvements should be vested in the said Board for the purpose of better enabling it to establish and maintain such institutions as aforesaid :

BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as 20 follows :—

1. The Short Title of this Act is "The Timaru Charitable Aid Short Title. Institution Vesting Act, 1890."

2. The lands described in the Schedule hereto, together with the Lands described in buildings, fixtures, and improvements thereon, are hereby vested in Schedule, and buildings, fixtures, 25 the South Canterbury Hospital and Charitable Aid Board for an estate and improvements

Hospital and Charitable Institutions Act, 1885," to sell, either by public auction or public tender, all or any part of the said lands, buildings, fixtures, and improvements, either together or separately, under 5 and subject to conditions to be approved by such Inspector; but all moneys received from such sale or sales shall be laid out and expended in or towards providing another site to be approved by such Inspector, and in erecting the necessary buildings, fixtures, and improvements thereon; or, in the event of the whole of the said land not being sold, 10 may, with such approval as aforesaid, be laid out and expended in or towards providing better accommodation, including new buildings, or additions, fixtures, and improvements on the portions of the land remaining unsold.

4. The said Board may also, with the consent of such Inspector, 15 let any of the said lands not required for immediate use in manner provided and with, under, and subject to the terms and conditions mentioned in sections eighty-four, eighty-five, and eighty-six of "The Hospital and Charitable Institutions Act, 1885;" but all rents and profits accruing therefrom shall be exclusively applied in or towards 20 the purposes of the said Charitable Aid Institution.
