#### A BILL INTITULED

# An Act to make certain provisions relating to the Waikawau Farm Park

BE IT ENACTED by the General Assembly of New Zealand 5 in Parliament assembled, and by the authority of the same, as follows:

- 1. Short Title—This Act may be cited as the Thames-Coromandel District Council (Waikawau Farm Park) Act 1985.
- 2. Interpretation—In this Act, unless the context otherwise 10 requires,—

"Commissioner" means the Commissioner of Crown Lands for the Hamilton Land District:

"Council" means the Thames-Coromandel District Council: "Park" means the Waikawau Farm Park, being the land described in the Schedule to this Act.

- **3. Grant in lieu of rates**—The Commissioner may pay to the Council a grant in lieu of rates in respect of that part of the park used for grazing.
- 4. Authority to lease—The Commissioner may grant a lease to any person of all or any part of the park for such period 5 or periods not exceeding in total 20 years, including any renewals thereof, on such terms and conditions as he thinks fit, for use as a camping ground.
- 5. Charging of fees—While a lease under section 4 of this Act is not subsisting, the Commissioner shall be entitled to 10 charge persons intending to camp on the park such fees as he considers reasonable after taking into account the cost of the maintenance and upkeep of the facilities and roading within or serving the park.
- **6. Payments to Council**—(1) The Commissioner shall pay 15 to the Council, by the 30th day of June in each year, in addition to the payment referred to in **section 3** of this Act, \$1 per occupied campsite per day.

(2) Any adjustment to that rate shall be by agreement

between the Council and the Commissioner.

(3) The campsite levy shall be for the period in each year ending 31 March.

- 7. Application of money received by Council—The Council shall apply all payments received under this Act as if the payments were charges made under section 142 of the 25 Local Government Act 1974 for the purposes of maintaining, repairing, and upgrading the roads in the Waikawau District leading to the park.
- **8. Camping-Grounds Regulations 1985 not to apply—**Nothing in this Act shall be construed as applying the Camping- 30 Grounds Regulations 1985 to the park.
