A BILL INTITULED

An Acr to make Special Provision for the Disposal of certain Title. Mining Privileges in the Hauraki Mining District.

BE IT ENACTED by the General Assembly of New Zealand 5 in Parliament assembled, and by the authority of the same, as follows :----

1. The Short Title of this Act is "The Thames Deep Levels Short Title. Enabling Act, 1906."

2. (1.) The Warden of the Hauraki Mining District may cause Improvements on 10 the improvements existing on the parcel of land, described in the land in Schedule may be sold. Schedule hereto (excepting therefrom the area therein mentioned) to be sold by public auction on such terms and conditions as he thinks fit and the Minister approves.

(2.) The sole right acquired by the purchaser shall be the right 15 to remove from the land the purchased improvements at any time within three months after the sale.

(3.) The proceeds of such sale shall be paid into the Public Account, and shall form part of the Consolidated Fund.

3. Upon the said parcel of land being made available for mining Righ's of purchaser. 20 purposes under "The Mining Act, 1905," the purchaser at such sale, if he has duly completed the purchase, shall have a prior right to a license for a special claim in respect to the said land if he makes application therefor within one month after the land is made available as aforesaid.
