A BILL INTITULED

AN ACT to constitute the Uawa County.

Title.

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Uawa County Act, 1918.

Short Title.

2. (1.) The Uawa County is hereby constituted, comprising that portion of the Cook County (particularly described in the *First* Schedule hereto) which at the date of the passing of this Act comprised the Tolaga Riding of the Cook County.

Uawa County constituted.

(2.) The boundaries of the Cook County as hereby altered are described in the *Second* Schedule hereto.

3. From and after the coming into operation of this Act no local authority other than the Uawa County shall within the limits of the said county exercise any jurisdiction or authority over any roads or over or in relation to any matter or thing in respect of which jurisdiction is conferred upon a County Council under any Act:

Jurisdiction of County Council.

Provided that nothing herein shall affect the power of the Governor-General to proclaim any portion of the said county a borough or town district.

FIRST SCHEDULE.

BOUNDARIES OF THE UAWA COUNTY.

ALL that area bounded towards the north generally by the Anaura Block from the sea at a point called Koangaumu to the Hikuwai River; thence by that river to the south-eastern corner of Tauwhareparae No. 1 Block; thence by the last-mentioned block and Tauwhareparae No. 3 Block to the south-western corner of the latter block; thence by the western boundary of the said Tauwhareparae No. 3 Block for a distance of

12800 links: thence by a line running due west, 12000 links, to Trig. Station No. 171, Puakato: thence by a line bearing  $262^{\circ}$ , distance 12400 links; bearing  $173^{\circ} 15'$ , distance 8700 links; bearing  $210^{\circ} 30'$ , distance 5200 links, to Rimututahi Trig. Station: thence by lines bearing  $314^{\circ}$ , distance 1400 links; bearing  $328^{\circ}$ , distance 1100 links; bearing  $294^{\circ} 30'$ , distance 2800 links; bearing  $349^{\circ} 41'$ , distance 5669 links; bearing  $345^{\circ} 21'$ , distance 1098 links; bearing  $344^{\circ} 29'$ , distance 10800 links; bearing  $74^{\circ} 30'$ , distance 4500 links; bearing  $9^{\circ} 30'$ , distance 6600 links; bearing  $273^{\circ}$ , distance 7500 links; bearing  $315^{\circ}$ , distance 1600 links; bearing  $298^{\circ} 30'$ , distance 11800 links; bearing  $267^{\circ}$ , distance 2550 links; bearing  $258^{\circ}$ , distance 4500 links; and bearing  $20^{\circ} 29'$ , distance 17000 links, to the southern boundary of Tauwhareparae No. 2B Block: thence by that block to the Mangamauku Stream; thence by that stream to the Mata River; thence by the right bank of the Mata River to the eastern boundary-line of Huiarua No. 1 Block; thence towards the west generally by the said Huiarua No. 1 Block, Waipaoa No. 2 Block, and Waipaoa No. 3B Block, to the Waingaromia River; thence to and along the middle of that river to the northernmost corner of Waingaromia No. 1c Block; thence by that block to the middle of the Waiapu Inland Road; thence by a line along the middle of that road to its junction with a road which intersects Small Grazing-run No. 42 in a southerly direction; thence by a line along the middle of the latter road to the south-western boundary-line of the said Small Grazing-run No. 42; thence on the south and west by Lot 1, Small Grazing-run 43A, to the centre of a road; thence by the centre of that road, running in a southerly direction through Small Grazing-run No. 43 to the junction of the road with a north-west boundary of Small Grazing-run No. 58, Lot 2; thence on the south by Small Grazing-run No. 58 to a point on the Mangarara Stream; thence on the south-west by portion of Small Grazing-run No. 58, Waimata North 1A 2, and again by Small Grazing-run No. 58; thence on the south by the northern boundary of the Waimata North No. 1 Block; thence on the south-east by the north-western boundary of Section 2, Block XIII, Waimata, to the Pakarae River; thence by the centre of the Pakarae River to the Pakarae No. 1 Block; thence on the south-west by the Pakarae No. 1 Block to the sea; thence on the east by the sea to Koangaumu, the starting-point.

## SECOND SCHEDULE.

### BOUNDARIES OF THE COOK COUNTY.

COMMENCING at the intersection of the road with the south-western boundary-line of the Small Grazing-run No. 42; thence by that boundary-line to Trig. Station No. 134; thence by Small Grazing-run No. 45 to the Kaitangata Stream; thence by that stream, the Hinakiwawahia Stream, and Small Grazing-run No. 44A to the easternmost corner of that run; thence by the southern boundary of the said Small Grazing-run No. 44A, by Waihora 2B Nos. 2 and 1 Blocks to the northernmost corner of Section 5, Block III, Waimata Survey District; thence towards the north-west generally by Papakorokoro Nos. 6 and 4 Blocks, to the Mangarueke Stream; thence by that stream to the easternmost corner of Ahirau No. 2G Block; thence by Ahirau Nos. 2G, 2F, 2C, and 2B Blocks to the Mangataikahu Stream; thence by that stream to the Waipaoa River; thence by a line to and along the middle of that river to the Pouarua Stream; thence by that stream to its first crossing of the road which runs up the valley of the said Pouarua Stream; thence along the middle of that road to Okahuatui 1D 2B No. 1 Block; thence by Tangihanga A, Pukupapa B, and Waikohu Blocks, and Subdivision 1 of Tangihanga No. 1c Block to the north-eastern boundary of the Ngatapa Settlement; thence by the north-eastern boundary of that settlement to the northernmost corner of Section 3, Block X, Waikohu Survey District, in Ngatapa Settlement; thence by the north-western and western boundaries of the said Ngatapa Settlement to the Tahora Road; thence along the middle of that road to the Wharekopae Stream; thence by a line along the middle of that stream to the Wharekopae No. 1A Lot 2; thence by the said Lot 2 and Hangaroa-Matawai B Nos. 4 and 1 Blocks to the Hangaroa River; thence by a line to and along the middle of that river to the confluence of the Kawaimango Stream with the said river; thence by the said Kawaimango Stream and Tahora Blocks 2c No. 1, Section 3, to the north-eastern corner of Section 1, Block VIII, Tuahu Survey District; thence by the last-mentioned section to the Gisborne-Waikaremoana Road; thence by a line to and along the middle of that road to Bushy Knoll

Road ; thence by a line along the middle of the last-mentioned road to the northernmost corner of Section 2, Block IX, Hangaroa Survey District ; and thence by Section 1, Block IX aforesaid, to its south-eastern corner ; thence towards the south-west by Sections 3 and 4, Block IX aforesaid, and Tauwharetoi 4B and 3B Blocks to the southernmost corner of Tauwharetoi 3A Block ; thence by the south-eastern boundary of the last-mentioned block to the Hangaroa River ; thence by a line to and along the middle of that river to a point in line with the eastern boundary of Mangapoike 2A No. 2 Block ; thence to and along the eastern boundary of that block to Lot 4 of Mangapoike 2A No. 3, along the northern boundary of that block, and the northern and eastern boundary of Lot 5 of the said Mangapoike 2A No. 3 to Mangapoike No. 2D Block ; thence along the northern boundary of that block to a right line running from the confluence of the Hangaroa and Ruakituri Rivers to the sea at Paritu ; thence by that right line to the sea ; and thence towards the east by the sea to the north-eastern corner of the Pakarae No. 1 Block, the said Pakarae No. 1 Block and its continuation westerly to the centre of Pakarae River, and by the centre of that river to a point in a line with the western boundary of Section 2 of Block XIII, Uawa Survey District ; thence by the north-western boundary of the said Section 2 to the northern boundary of Waimata North No. 1 Block ; thence by the northern boundaries of the said Waimata North No. 1 Block, Small Grazing-run No. 58, Waimata North No. 1A 2, and again by Small Grazing-run 58 and the continuation of its northern boundary westerly to the centre of the road at the southern boundary of Small Grazing-run No. 43 ; on the west generally by the centre of that road to its intersection with the eastern boundary of Small Grazing-run No. 43A ; thence by the eastern and northern boundaries of Small Grazing-run No. 43A aforesaid to the eastern boundary of Waikohu County, the point of commencement: excluding the Borough of Gisborne and the Mangapapa Town District.
