BE IT THEREFORE ENACTED by the General Assembly of New Preamble. Zealand in Parliament assembled and by the authority of the same as follows

1. The Short Title of this Act shall be "The Vaccination Act Short Title. 1870" It shall come into operation on the first day of It shall come into operation on the first day of thousand eight hundred and seventyand the said day shall be 10 deemed the time of the commencement of this Act.

It shall be lawful for the Governor from time to time to divide any portion of the Colony of New Zealand not included within the boundaries of any Province or such part of any such portion as he 15 shall think fit into convenient districts for affording increased facilities for vaccination and from time to time to alter the boundaries of such districts heretofore formed or hereafter to be formed and from time to time to appoint a convenient place or places in each such district for the performance of such vaccination and to take the most effectual 20 means for giving from time to time to all persons resident within such district due notice of the days and hours at which a Public Vaccinator to be by the Governor appointed will attend at such place to vaccinate all persons not already successfully vaccinated who may then appear there and also of the days and hours at which such Public Vaccinator 25 will attend at such place to inspect the progress of such vaccination in the persons so vaccinated.

The Superintendent of every Province in New Zealand may divide the Province of which he is Superintendent or such part thereof as he shall think fit into convenient districts for affording increased 30 facilities for vaccination and from time to time divide into such districts any part of such Province not previously divided into such districts and from time to time alter the boundaries of any such districts heretofore formed or hereafter to be formed within such Province and shall from time to time appoint a convenient place or 35 places in each such district for the performance of such vaccination and shall take the most effectual means for giving from time to time to all persons resident within such district due notice of the days and hours at which a Public Vaccinator to be by such Superintendent appointed will attend at such place to vaccinate all persons not 40 already successfully vaccinated who may then appear there and also of the days and hours at which such Public Vaccinator will attend at such place to inspect the progress of such vaccination in the persons so vaccinated.

6. The Governor may appoint for each district constituted in any 45 part of the Colony not being within any Province one or more medical practitioners for the performance of vaccination of persons resident within such district and every such Medical Practitioner shall be termed a Public Vaccinator of the district and also such other person or persons as he may think fit to enforce in such district the provisions 50 of this Act and every such person so appointed to enforce the provisions of this Act shall be termed a Vaccination Inspector of such district and the Governor may from time to time remove any such Public Vaccinator or Vaccination Inspector and appoint another in his stead and every Public Vaccinator and Vaccination Inspector shall 55 be paid out of moneys to be appropriated by the General Assembly for the purpose such annual salary as the Governor shall from time to time appoint and all moneys so expended shall by the Colonial Treasurer be charged against the County or other division of the Colony in respect of which it is expended.

In any prosecution for neglect to procure the vaccination of a child it shall not be necessary in support thereof to prove that the defendant had received from the Registrar or any other officer any notice by this Act directed to be given or any other notice of the requirements of the law in this respect But if the defendant produce any of the said certificates hereinbefore described of or shall produce the register kept by the Registrar of Births in which the certificate of successful vaccination of such child shall be duly entered as hereinbefore provided the same shall respectively be a sufficient defence for him except in regard to the certificate (B) when the time therein 10 specified for the postponement of the vaccination shall have expired before the time when the information shall have been laid.
