### A BILL INTITULED

An Act to amend the Wellington and Karori Sanitation and Title. Water-supply Act, 1912.

BE IT ENACTED by the General Assembly of New Zealand 5 in Parliament assembled, and by the authority of the same, as

1. This Act may be cited as the Wellington and Karori Sani- Short Title. tation and Water-supply Amendment Act, 1915, and shall form part of and be read together with the Wellington and Karori Sanitation 10 and Water-supply Act, 1912 (hereinafter referred to as the principal

2. The Schedule to the principal Act is hereby repealed, and schedule to the Schedule hereto substituted in lieu thereof; and the words "the principal Act said area" where used in this Act or in the principal Act shall refer 15 to the area described in the Schedule hereto.

3. If the Wellington Council shall make claim against the Claim of Wellington Karori Council under section twelve of the principal Act for payment of moneys expended by the Wellington Council in connection with the preparation of the principal Act and the passing of the same 20 through Parliament and of the costs and expenses incurred by the allocatur of the Wellington Council in connection with the taking of polls for loans authority to Karori under the principal Act, such claim shall be made in writing and Council to make shall set out in reasonable detail the several charges making up payments. the amount thereof, and shall be taxed by the Registrar of the 25 Supreme Court, at Wellington, on the application of either the

Wellington Council or the Karori Council; and the allocatur of such Registrar shall be sufficient authority to the Karori Council to collect as hereinafter mentioned the amount thereby allowed from the ratepayers in the said area. No. 42—2.

Council against Karori Council under section 12 of the principal Act to be taxed. The Amount allowed by Registrar, with cost of collection, charged on the said area and to be collected as a rate. 4. (1.) The amount allowed by the Registrar as aforesaid, together with the cost of collecting the same, shall be a charge payable by means of a rate upon the rateable property within the said area; and on receipt of the allocatur of the Registrar the Karori Council shall forthwith by resolution make and levy on all rateable property within the said area, and on the basis of the unimproved value thereof, such a rate as will return to the Karori Council such amount with five pounds per centum thereon added thereto for the costs of collection.

(2.) Such rate shall be payable in one sum or more sums on the 10

day or days named in the resolution aforesaid.

(3.) Such resolution shall state such rate to be an amount in the pound on the rateable values of the rateable property in the said area as appearing in the valuation roll for the time being in force in the

Borough of Karori.

(4.) Such rate shall have all the incidents of a rate made under Part XI of the Municipal Corporations Act, 1908, but it shall not be necessary for the Karori Council to give any public notification pursuant to section fifty of the Rating Act, 1908.
