AN ACT to confer Further Powers on the Wellington Title. City Council in respect of the Hutt Road as defined in the Hutt Road Act, 1915, and for that Purpose to amend the Hutt Road Amendment Act, 1917, and the Wellington City and Suburban Highways Construction and Hutt Road Amendment Act. 1924, and the Wellington City and Suburban Highways Construction and Hutt Road Amendment Act, 1930; to amend the Finance Act, 1927 (No. 2), and the Wellington City Empowering and Amendment Act, 1932.

## 2 Wellington City and Suburban Highways Construction and Hutt Road Amendment and Empowering

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows :---

1. This Act may be cited as the Wellington City and Suburban Highways Construction and Hutt Road Amend-5 ment and Empowering Act, 1933.

2. In this Act, unless inconsistent with the context,—

- "Hutt Road" means the Hutt Road as defined by the 1915 Act:
- "1915 Act" means the Hutt Road Act, 1915: 10
  "1917 Act" means the Hutt Road Amendment Act, 1917:
- "1924 Act" means the Wellington City and Suburban Highways Construction and Hutt Road Amendment Act, 1924.

**3.** (1) The operation of subsection two A of section nine of the 1917 Act, as set out in paragraph (d) of subsection two of section five of the 1924 Act, is hereby suspended for the financial year ending on the thirtyfirst day of March, nineteen hundred and *thirty-five*: 20

Provided that no greater sum than two thousand three hundred and thirty pounds shall be payable by the local authorities as contributions under section six of the 1915 Act in respect of that year.

(2) The amount of such contributions may be expended 25 not only in the maintenance of the Hutt Road, but also in the provision of a cycle-track and a footway on such portion of the Hutt Road as is not appropriated for carriageway.

(3) The Council may indicate the division between 30 any such cycle-track and any such footway by fence, kerb, or painted line.

4. The Board may, if it thinks fit, apply any moneys held by it on the thirty-first day of March, nineteen hundred and thirty-four, that may be used pursuant 35 to the provisions of the Acts mentioned in section seven hereof for the maintenance of roads and streets in the City of Wellington, or in the Wellington suburban area, for the purpose of constructing, renewing, maintaining, or repairing any cycle-track or footway constructed or 40 provided pursuant to the provisions of the *last preceding* section.

Definitions.

**Operation** of subsection (2A) of section 9 of the Hutt Road Amendment Act, 1917, temporarily suspended and increased contributions authorized to be expended not only for maintenance but for provision of cycle-track and footway.

### Wellington City and Suburban Highways 3 Construction and Hutt Road Amendment and Empowering

5. Section thirty-three of the Finance Act, 1927 Amendment of (No. 2), is hereby amended by adding thereto the section 33 of the Finance Act, following new subsection three :---

"(3) The provisions of section nine of the Hutt Road 5 Amendment Act, 1917, as amended by section five of the Wellington City and Suburban Highways Construction and Hutt Road Amendment Act, 1927, whereby the contributions by local authorities in respect of the maintenance of the Hutt Road are limited to one thousand

10 pounds, shall have effect during every year in which the Wellington City Council has received payment of an amount sufficient to satisfy the charges referred to in subsection one hereof, or has obtained from the Main Highways Board an assurance that it will receive such 15 amount during that year."

6. Section three of the Wellington City and Suburban Repeal. Highways Construction and Hutt Road Amendment Act, 1930, is hereby repealed.

7. - "Provided that the expenditure on such sewer 40 extension shall not exceed twenty-three thousand pounds."
