- AN ACT to vest Portion of the Bolton Street Cemetery in the Mayor, Title. Councillors, and Citizens of the City of Wellington for the Purposes of a Street.
- 5 BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows :--

1. This Act may be cited as the Wellington City Empowering Short Title. Act, 1928.

Definitions.

"Corporation" means the Corporation of the Mayor, Councillors, and Citizens of the City of Wellington.

"Council" means the Wellington City Council.

3. The lands described in the Schedule hereto are hereby vested Vesting of portion of Bolton Street Cemetery and 15 in the Corporation for the purposes of a street freed and discharged from all rights or easements of burial. Anderson Park in

(2) All monuments and gravestones situate on the lands described in the Schedule hereto shall be re-erected in a position approved by the 25 Minister of Health of otherwise disposed of to his satisfaction.

(3) The Council shall erect in some prominent place in some cemetery owned by the Corporation a monument approved by the Minister of Health containing a record of the names of all persons whose remains have been reinterred so far as the Council can by investigation ascertain the names of such persons.

SCHEDULE.

THOSE pieces of land situate in the City of Wellington being as follows :----

1. All that piece of land containing 1 rood 9.51 perches, be the same a little more or less, being part of the Bolton Street Cemetery, as the same is delineated on the plan prepared by Frederic Charles Basire dated the 10th July, 1928, and thereon coloured yellow.

2. All that piece of land containing 1.25 perches, be the same a little more or less, being portion of the Bolton Street Cemetery, and being part of the land which was originally Jewish Cemetery, as the same is delineated on the said plan, and thereon coloured neutral.

3. All that piece of land containing 2 roods 34.59 perches, be the same a little more or less, being portion of Anderson Park and portions of the land which was originally known as "Church of England Cemetery, Number 3," and "Public Cemetery, Number 5," as the same is delineated on the said plan, and thereon coloured red.

4. All that piece of land containing 6.42 perches, be the same a little more or less, adjoining the said land coloured red, being portion of closed road, as the same is delineated on the said plan, and thereon coloured blue.
