WELLINGTON CITY MILK-SUPPLY AMENDMENT.

[LOCAL BILL.]

A BILL INTITULED

AN ACT to amend the Wellington City Milk-supply Act, 1910, and the Wellington City Empowering and Amendment Act, 1911. Title.

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Wellington City Milk-supply Amendment Act, 1914. Short Title.

10 2. (1.) Section five of the Wellington City Milk-supply Act, 1910 (hereinafter referred to as the principal Act), is hereby amended— Amendments of Wellington City Milk-supply Act, 1910.

(a.) By repealing the words "in the manner prescribed by the Local Bodies' Loans Act, 1908," at the end of the section; and

15 (b.) By substituting in lieu thereof the words "raised under the Local Bodies' Loans Act, 1913, by special order and without taking the steps described in sections eight to twelve of the Local Bodies' Loans Act, 1913."

20 (2.) Section eight of the principal Act is hereby amended by repealing the following words at the beginning of the section: "Subject to the provisions of this Act relating to milk brought into the city by road."

*Struck out.*

25 (3.) Paragraph (f) of section eleven of the principal Act is hereby repealed.

(4.) Paragraph (b) of section eighteen of the principal Act is hereby repealed.

*New.*

(3A.) Section nine of the principal Act is hereby amended by striking out the words "may, while a milk-station is available as aforesaid, be brought into the city by road and there sold" and en- 5  
 acting in lieu thereof the words "produced at dairies in the city  
 may, while a milk-station is available as aforesaid, be sold in the  
 city"; and by adding at the end of the section the following new  
 paragraph, namely:—

"(e.) That no person shall, under any license granted under  
 paragraph (d) hereof, sell more than thirty gallons of 10  
 milk in any one day."

(4A.) Paragraph (f) of section eleven of the principal Act is  
 hereby amended by repealing the words "introduction by road and"  
 in the first line thereof.

(5.) Paragraph (b) of section eighteen of the principal Act is 15  
 hereby amended by repealing the words "brought into the city and  
 sold" in the first line thereof, and enacting in lieu thereof the words  
 "sold in the city."

3. The power conferred by section six of the Wellington City  
 Empowering and Amendment Act, 1911, shall be exercisable only in 20  
 respect of milk-stations in which the business of selling and dis-  
 tributing milk in wholesale quantities is being carried on on the  
 commencement of this Act.
