# A BILL INTITULED

An Act to amend "The Wellington City Reserves Tillo. Act 1872 Amendment Act, 1877."

THEREAS a survey has been made of the several pieces of land Preamble. referred to in the Schedule to "the Wellington City Reserves Act 1872 Amendment Act, 1877 (herein referred to as "the said Act," and it is found that the proper measurements and boundaries thereof 5 differ materially from those set forth in the Schedule to the said Act), and it is expedient to repeal the said Schedule, and to declare that the powers and provisions of the said Act shall relate to and affect the pieces of land described in the Schedule hereto:

BE IT THEREFORE ENACTED by the General Assembly of New 10 Zealand in Parliament assembled, and by the authority of the same,

as follows :--

1. The Short Title of this Act shall be "The Wellington City Short Title. Reserves Act 1872 and 1877 Amendment Act, 1878."

2. The Schedule to the said Act is hereby repealed.

3. The second section of the said Act shall be deemed to relate to Schedules in substithe land described in the first part of the Schedule hereto, and the schedule. third section of the said Act to the land described in the second part of the said Schedule hereto, and the said Act shall be read and construed accordingly.

### FIRST PART.

# HOSPITAL RESERVE.

All that parcel of land containing by admeasurement 2 roods and 9 perches, more or less, being Lot No. 1 of land described in Special Grant No. 46 to the Wesleyans. Bounded towards the North-east by Wesley Road, 205 links; towards the East by a public road, 283 links; and towards the South-west and North-west by the Botanical Gardens, 345 links and 183½ links respectively.

Also all that other parcel of land containing by admeasurement 1 acre 1 rood and 10 perches, more or less, being Lots No. 2 and 3 of land described in the said grant.
