- An Act to enable the Wellington City Corporation and the Title. Wellington Harbour Board respectively to carry out certain Reclamation and other Works.
- BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows :—
 - 1. The Short Title of this Act is "The Wellington City Short Title. Reclamation and Public Baths Act, 1898."

It shall be lawful for the Governor to grant to the Corpora- Governor may grant 15 tion for the purpose of widening Clyde Quay and Oriental Terrace, being public streets of the city, a strip of land, being part partly Quay and Oriental foreshore and partly a portion of the Harbour of Wellington, commencing at the eastern boundary of the land described in a certain

Such land shall thereupon vest in the Corporation, and shall be held by the Corporation as and for the purposes of a public street, and with power to reclaim the same from the sea for that purpose.

4. It shall be lawful for the Governor to grant unto the Governor may grant 30 Corporation a parcel of land covered by water, and being part of the for baths.

Harbour of Wellington, having two hundred and fifty feet frontage to Clyde Quay (treated as widened as aforesaid), by a depth of two hundred and fifty feet, when and so soon as the position of the said parcel of land shall have been agreed upon between the Board and the Corporation. Such land shall be held by the Corporation for the purpose of erecting and maintaining thereon public baths, and for no other purpose, and with power to execute any reclamation or other works for or in connection with the construction of such baths only. If the Corporation shall not have constructed the said baths within five years of the coming into operation of this Act the right to use the 10

land for that purpose shall absolutely cease.

5. On and until the completion of the reclamation authorised in Board's foreshore section three, the Board shall have the same rights to the foreshore of such reclamation as it now has in respect of the existing foreshore.

The foreshore of the land referred to in section four shall, by force of 15 this Act, revest in the Board if the Corporation shall not, within five years from the passing of this Act, have bona fide started to con-

struct public baths upon the said land.

6. It shall be lawful for the Board and the Board is hereby authorised to construct a concrete wall on the western boundary of 20 the land referred to in section four for a length of two hundred and fifty feet projecting from Clyde Quay (treated as widened as afore-The Board shall so construct such wall that it can be used as and for the western wall of the said baths. The said wall shall be vested in the Board and the Corporation as a party-wall, each party being 25 entitled to one-half in thickness thereof.

7. The Corporation and the Board respectively may, by any agreements between such parties heretofore or to be hereafter made, require either party to execute all or any part of any work authorised by this Act to be executed by such party, and make the consent of 30 either party necessary to the construction of any work authorised by this Act, or to the plans thereof, and impose upon either party the duty of maintaining and repairing, or joining in maintaining or repairing, any work or any part thereof hereby authorised, and make provisions as to the joint mode of construction, ownership, and use of 35 the said party-wall, and generally in respect of as to the subjectmatters of this Act or any of them.

Special Act.

8. This Act shall be deemed a special Act within the meaning of "The Harbours Act, 1878."
