A BILL INTITULED

An Acr to vest certain of the Foreshores and Mud-flats within Title. the Harbour of Whangarei in the Whangarei Harbour Board.

BE IT ENACTED by the General Assembly of New Zealand 5 in Parliament assembled, and by the authority of the same, as follows:

1. (1.) This Act may be cited as the Whangarei Harbour Board Short Title.

Vesting Act, 1917.

(2.) This Act shall be deemed to be a special Act within the 10 meaning of the Harbours Act, 1908, and the amendments thereof, which are accordingly incorporated herewith, and shall be read and construed along with the Whangarei Harbour Act, 1907.

2. On the passing of this Act the lands described in the Sche- Vesting of foreshore dule hereto shall vest in and be the property of the Whangarei 15 Harbour Board (hereinafter called the Board) as endowment

lands.

3. Notwithstanding the said lands shall be vested in the Board, Resumption it shall be lawful for the Governor-General, in pursuance of the Public Works Act, 1908, or its amendments, to take and proclaim any part 20 or parts thereof not actually occupied for the purposes of a railway or railways or roads without paying compensation therefor.
