A BILL INTITULED

An Act to constitute the Waimate North County.

Title.

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as 5 follows:

1. The Short Title of this Act is "The Waimate North County Short Title. Act, 1906."

2. This Act shall come into operation on the first day of April, Date of coming one thousand nine hundred and seven.

into operation.

3. The Waimate Road District is hereby abolished, and in lieu Waimate North 10 thereof the Waimate North County is hereby constituted, and shall County constituted. comprise the Waimate Road District and part of the Egmont County, the area and boundaries of which are more particularly described in the Schedule hereto. The boundaries of the Hawera County and 15 the Egmont County are hereby altered accordingly, and the said Waimate Road District shall be deemed to be merged in the Waimate North County hereby constituted.

4. From and after the coming into operation of this Act, and Authority of during the existence of the county hereby constituted, no local body County Council. 20 or authority other than the County Council shall within the limits of the said county be created, or exercise any jurisdiction or authority over any roads or over or in relation to any matter or thing in respect of which jurisdiction is conferred upon a County Council under the provisions of "The Counties Act, 1886," or any amendment thereof, 25 or otherwise.

ALL that area in the Land District of Taranaki bounded by a line commencing at the south-west corner of Section 1, Block V, Waimate Survey District; thence proceeding north to the south boundary of Section 20, Block I, Waimate Survey District; thence due west to the middle of the Oeo Road, opposite to the south-west corner of Section 20, Block I, Waimate Survey District; thence by a line along the middle of the Oeo Road to a point on Section 15, Block I, Waimate Survey District, opposite

to the south-east corner of Section 29, Block XIII, Kaupokonui Survey District; thence west to the south-west corner of Section 29, Block XIII, Kaupokonui Survey District; thence northerly along the west boundary-line of the Kaupokonui Survey District to the north-west corner of Section 27, Block XIII, Kaupokonui Survey District; thence in an easterly direction along the north boundary-line of Section 27, Block XIII, Kaupokonui Survey District to the south-west corner of Section 5, Block XIII, Kaupokonui Survey District; thence northerly along the west block-line of the Kaupokonui Survey District to the south-west corner of Subsection 13, Railway Reserve, Block IX, Kaupokonui Survey District; thence easterly by the south boundary-line of Subsection 13, Block IX, Kaupokonui Survey District to the southwest corner of Subsection 14, Block IX, Kaupokonui Survey District; thence due north to the north-west corner of Section 30, Block IX, Kaupokonui Survey District; thence east along the north boundary-line of the said section to the south-west corner of Section 24, Block IX, Kaupokonui Survey District; thence due north to the north-west corner of Section 16, Block IX, Kaupokonui Survey District; thence east along the north boundary-line of the said section to the south-west corner of Section 11, Block IX, Kaupokonui Survey District; thence due north to the middle of the Opunake Road; thence by a line along the middle of the Opunake Road to its junction with the Wiremu and Oeo Roads; thence north by a line along the middle of the Oeo Road to the north-west corner of Section 12, Block V, Kaupokonui Survey District; thence east along the north boundary-line of the said section to the south-west corner of Section 11, Block V, Kaupokonui Survey District; thence due north by the west boundary-lines of Sections 11 and 10, Block V, Kaupokonui Survey District to the radius-line of Mount Egmont; thence northerly, in a direct line to the summit of Mount Egmont; thence southerly in a direct line from the summit of Mount Egmont to the north-east corner of Section 11, Block VI, Kaupokonui Survey District; thence south by a line along the eastern boundary-lines of Sections 11, 13, and 16, of Block VI, Kaupokonui Survey District to the middle of the Opunake Road; thence easterly by a line along the middle of the Opunake Road to the middle of the Mangawhero-iti River; thence south by a line along the middle of the said Mangawhero-iti River to the north-east corner of Section 78, Block X, Kaupokonui Survey District; thence due east along the north boundary-line of Section 79, Block X, Kaupokonui Survey District to the middle of the Rowan Road; thence northerly by a line along the middle of the Rowan Road to the north-west corner of Section 80, Block XI, Kaupokonui Survey District; thence by a line along the northern boundary-line of Block XI, Kaupokonui Survey District due east to the middle of the Palmer Road; thence south by a line along the middle of the Palmer Road to the northern boundary-line of Section 147, Block IV, Waimate Survey District; thence by a line due west to the north-east corner of Section 75, Block III, Waimate Survey District; thence by a line in a southerly direction along the eastern boundary-line of Block III, Waimate Survey District to the Inaha Road; thence west to the middle of the Inaha Road; thence by a line along the middle of the Inaha Road to the sea; and thence towards the west by the sea to the place of commencement, the sea being the southern boundary.
