A BILL INTITULED

AN ACT to validate an Order in Council and Proceedings subsequent Title. thereto in respect of Land at Waipa.

- WHEREAS by an Order in Council dated the ninth day of August, Preamble. 5 one thousand eight hundred and eighty-seven, purporting to be made in pursuance of the powers and authorities conferred upon the Governor by "The Native Land Court Act, 1886," after reciting that it was necessary that the ownership of certain lands, which are described in the Schedule to this Act, should be ascertained, and that
- 10 it should be determined to whom and in what manner grants for the said lands should be issued, it was ordered and declared that the investigation of the ownership of the said lands, and the determination to whom and in what manner Crown grants therefor should issue, and all matters incidental thereto respectively, should be within the
- 15 jurisdiction of the Native Land Court: And whereas at a sitting of the Native Land Court at Hamilton, on the third day of July, one thousand eight hundred and eighty-nine, and following days, the said matters so ordered and declared as aforesaid were investigated and determined, and certain orders were made in relation thereto: And
- 20 whereas doubts have arisen as to the validity of the said Order in Council and the subsequent proceedings in relation thereto, and it is expedient that such doubts should be removed :

BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, 25 as follows :---

1. The Short Title of this Act is "The Waipa Order in Council Short Title. Validation Act, 1889."

2. The said Order in Council is hereby declared to be and shall order in Council be deemed to have been as valid and effectual as if the same had been validated.
