A BILL INTITULED

An Act to amend the Widows' Pensions Act, 1911.

Title.

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as 5 follows:-

1. This Act may be cited as the Widows' Pensions Amendment Short Title. Act, 1912, and shall form part of and be read together with the Widows' Pensions Act, 1911 (hereinafter referred to as the principal

Act). 2. In the principal Act and this Act, unless a contrary intention Definition of appears, the expression "widow" shall be deemed to extend to and include any woman whose husband is detained in an institution

under the Mental Defectives Act, 1911, if the Magistrate to whom application for a pension-certificate under the principal Act is made 15 finds, upon the certificate of a two duly qualified medical practitioners, that the husband is incurable or likely to be incurable for the period of at least twelve months after the granting of a pension-certificate.

3. Section two of the principal Act is hereby amended by omit- Section 2 of ting from the definition of "pension-year" the words "made on principal Act 20 which that certificate is issued," and substituting the word "established."

4. Notwithstanding anything in section five of the principal Section 5 of Act, that Act shall apply to—

(a.) Any child born out of New Zealand if its mother was only temporarily absent from New Zealand at the time of its birth; and

(b.) Any child born out of New Zealand if its mother has continuously resided in New Zealand for not less than ten years immediately preceding the date of an application for a pension under the principal Act:

Provided that continuous residence in New Zealand shall not be deemed to have been interrupted by

occasional absences therefrom if she establishes the fact that during such absences her family or home was in New Zealand.

Section 5 of principal Act amended.

"Annual income" defined.

4_A. Section five of the principal Act is hereby amended by omitting from paragraph (b) the words "unless legitimated by the subsequent marriage of the parents," and substituting the words "unless after the birth of the child its parents have intermarried."

5. (1.) The term "annual income" as used in the principal Act and this Act means all moneys, valuable consideration, or profits 10 derived or received from any source for the year immediately preceding the pension-year by a widow and any of her children to whom the principal Act applies, for their own use or benefit, and includes the constructive income computed in accordance with subsections three and four of this section, but does not include any pension 15 payable under the principal Act, nor any relief received from any charitable institution:

Provided that where a widow is at the date of her application entitled to receive from any source during the pension-year periodical payments of money on behalf of herself or of any of her children 20 as aforesaid such money shall be included in the computation of the annual income, although no part thereof was actually received during the year immediately preceding the pension-year.

(2.) There shall be deducted from the annual income any personal earnings of the applicant not exceeding the sum of one hundred 25

pounds.

(3.) If a widow or any of her children to whom the principal Act applies is the owner of any property which produces no income, or which produces an income less than five per centum of the value of that property, the widow or child shall for the purposes 30 of this Act be deemed to be in receipt from that property of an

annual income equal to five per centum of the value thereof.

(4.) If a widow or any of her children to whom the principal Act applies is the owner of a sum of money not otherwise chargeable as income, and any portion of that sum is expended in any year 35 in the maintenance of the widow and her children as aforesaid in excess of the amount which, with the actual income and any pension payable, is required to make up ninety pounds where there is one such child, one hundred and ten pounds where there are two such children, and one hundred and thirty pounds where there 40 are three or more such children, the sum so expended in excess shall be included in the computation of the annual income.

(5.) If a widow or any of her children to whom the principal Act applies is in receipt of any income which is partly derived from property and is partly personal earnings in respect of that property, 45 the Magistrate to whom the application for a pension-certificate is made shall apportion that income in such manner as he thinks just between the income derived from such property and such personal

earnings.

(6.) Money received on the sale or exchange of land or other 50 property and money received under an insurance policy on the destruction or damage by fire or otherwise of a building or other property shall not be included in the computation of the annual income.

(7.) This section is in substitution for section eight of the Repeal.

6. (1.) In addition to the powers conferred by section twenty- Review of pensionthree of the principal Act, the Magistrate may at any time, on the certificate on 5 application of the Commissioner, review any pension-certificate circumstances of during the currency thereof on the ground of the altered circum- pensioner. stances of the pensioner, and may either cancel the same or vary the same in such manner as he thinks fit, having regard to the provisions of the principal Act and this Act.

(2.) Any order so made by the Magistrate shall take effect as from the date of the order or from such other date as is fixed by the order.

7. Notwithstanding anything in section twenty of the principal on death of 15 Act, if a widow in receipt of a pension under that Act dies, widow, guardian may receive the guardian or other person for the time being having the pension on behalf care or control of her children to whom the Act applies shall, subject to the provisions of the said Act and with the approval of the Commissioner, be entitled to receive the pension to which the widow 20 would have been entitled in respect of her children if she had lived.
