A BILL INTITULED

An Act to amend the War Pensions Act 1954

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, 5 as follows:

- 1. Short Title and commencement—(1) This Act may be cited as the War Pensions Amendment Act 1962, and shall be read together with and deemed part of the War Pensions Act 1954* (hereinafter referred to as the principal Act).
- 10 (2) Except where this Act otherwise provides, this Act shall be deemed to have come into force on the twentieth day of June, nineteen hundred and sixty-two.

- 2. Increasing rates of disablement pensions—The principal Act is hereby amended by repealing the First Schedule (as substituted by section 2 of the War Pensions Amendment Act 1957), and substituting the First Schedule set out in the First Schedule of this Act.
- 3. Increasing rates of widows' pensions—In respect of the period which commenced on the twentieth day of June, nineteen hundred and sixty-two, and ended with the seventeenth day of July, nineteen hundred and sixty-two, the principal Act shall be deemed to have effect as if it had 10 been amended as follows:
 - (a) By omitting from paragraph (a) of clause 1 of the Fourth Schedule (as substituted by section 3 of the War Pensions Amendment Act 1960) and also from clauses 3 and 5 of that Schedule the expression 15 "£3 7s. 6d.", and substituting in each case the expression "£3 15s.":
 - (b) By omitting from clause 3 of the Seventh Schedule (as substituted by section 5 of the War Pensions Amendment Act 1960) the words "£422 10s. per annum", 20 and substituting the words "£442 per annum".
- 4. Increasing rates of war pensions and allowances—
 (1) The principal Act is hereby further amended by repealing the Third and Fourth Schedules (as substituted by section 3 of the (Social Security) War Pensions Amendment 25 Act 1960), the Fifth Schedule (as substituted by section 2 of the (Social Security) War Pensions Amendment Act 1958), and the Sixth and Seventh Schedules (as substituted by section 5 of the (Social Security) War Pensions Amendment Act 1960), and substituting the Third, Fourth, Fifth, Sixth, 30 and Seventh Schedules set out in the Second Schedule of this Act.
 - (2) The following enactments are hereby repealed:
 - (a) Section 2 of the War Pensions Amendment Act 1958 and the Schedule to that Act:

Provided that a War Pensions Board may in its discretion refuse to increase any economic pension under this clause in any case where in the opinion of the Board the claimant or pensioner is sharing household

expenses with any other person.

- £78 per annum, diminished by £1 for every complete £1 of the total annual income of the veteran and his wife (exclusive of any allowance under Part VI of this Act) in excess of £78 per annum.
- £39 per annum, diminished by £1 for every complete £1 of the total annual income of the veteran and her husband (exclusive of any allowance under Part VI of this Act received by the female veteran) in excess of £344 10s, per annum.
- £39 per annum, diminished by £1 for every complete £1 of the total annual income of the veteran and his wife (if any) (exclusive of any allowance under Part VI of this Act) in excess of £117 per annum.

3. Under section 74—

Special allowance where Not exceeding £448 10s. per veteran dies leaving widow annum. or dependent child

4. General-

The rates specified in clause 1 of this Schedule shall be increased by £26 per annum in any case where the person claiming or in receipt of the allowance is an unmarried person:

Provided that a War Pensions Board may in its discretion refuse to increase any allowance under this clause in any case where in the opinion of the Board the person claiming or in receipt of the allowance is sharing household expenses with any other person."
