

## **WAR PENSIONS (RATES OF PENSIONS AND ALLOWANCES) ORDERS CONFIRMATION BILL**

---

### EXPLANATORY NOTE

THIS Bill validates and confirms various Orders in Council which increased the rates of various war pensions and allowances, as required by section 75c of the War Pensions Act 1954.

*Clause 1* relates to the Short Title.

*Clause 2* validates and confirms the War Pensions (Rates of Pensions and Allowances) Order 1984 notwithstanding that it was not validated and confirmed by an Act of Parliament passed during the session of Parliament that ended on 14 June 1984.

*Clause 3: Paragraph (a)* validates and confirms, in respect of the periods they were in force, various Orders in Council (now revoked) which increased various war pensions and allowances.

*Paragraph (b)* validates and confirms 2 Orders in Council, increasing various war pensions and allowances, which are currently in force.

A BILL INTITULED

**An Act to validate and confirm Orders in Council made under section 75C of the War Pensions Act 1954**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the War Pensions (Rates of Pensions and Allowances) Orders Confirmation Act 1985.
- 10 2. **Order not validated in time by Act of Parliament confirmed**—The Order in Council specified in the First Schedule to this Act is hereby validated and confirmed in respect of the period it purported to be in force notwithstanding that it was not validated and confirmed in respect of that period  
15 by an Act of Parliament passed during the session of Parliament that ended with the 14th day of June 1984, as required by section 75C of the War Pensions Act 1954.

**3. Other orders confirmed**—As required by section 75c of the War Pensions Act 1954—
