A BILL INTITULED

An Act to vest in the Mayor, Councillors, and Burgesses of the Title. Borough of Westport, Sections 986 and 987, containing Ten Acres and Eight Perches, known as Victoria Square, in the Town of Westport; and Section 11, Block III, Kawatiri Survey District, also known as Section 1002, Town of Westport, containing Twelve Acres One Rood Thirty-seven Perches, in the Town of Westport, known as the Beach Reserve; and One Acre One Rood, formerly Part of Queen Street, between the aforesaid Sections 986 and 987, Town of Westport.

WHEREAS certain public domains known as Victoria Square and Preamble. the Beach Reserve, being Sections 986 and 987, Town of Westport, and Section 11, Block III, Kawatiri Survey District, also known as Section 1002, Town of Westport, are vested in the Westport (2) 15 Domain Board under Part II of the Public Reserves and Domains Act, 1908: And whereas the Westport Borough Council is seised of the freehold of one acre one rood, formerly part of Queen Street, between the aforesaid Sections 986 and 987, in the Town of Westport: And whereas the Westport Borough Council is the said Domain

20 Board: And whereas the Westport Borough Council has raised and expended certain loan-moneys on the said public domains: And whereas it is expedient to vest the said public domains in the Westport Borough Council:

Be it therefore enacted by the General Assembly of New 25 Zealand in Parliament assembled, and by the authority of the same, as follows:—

- 1. This Act may be cited as the Westport Public Parks Vesting Short Title. Act, 1913.
- 2. The said public domains known as Victoria Square and the Vesting Victoria 30 Beach Reserve, described in the First, Second, and Third Schedules Square and Beach Domain in Westport

Borough Council.

hereunder written, are hereby vested in the Mayor, Councillors, and Burgesses of the Borough of Westport as pleasure-grounds within the meaning of section two hundred and ninety-nine of the Municipal Corporations Act, 1908; and the Westport Borough Council shall have and be deemed to have had the like power to raise and expend loan-moneys on the said domains as a Borough Council has by law in respect of pleasure-grounds within the said section two hundred and ninety-nine.

FIRST SCHEDULE.

VICTORIA SQUARE.

ALL that parcel of land, being Section 986, Town of Westport, containing by admeasurement 5 acres and 5 perches: bounded on the north by Lyndhurst Street, 501.9 links; on the east by a parcel of land, formerly part of Queen Street, 1002.5 links; on the south by Brougham Street, 501.9 links; on the west by Russell Street, 1002.5 links, to the commencing-point: be the said area and linkages a little more or less.

Also all that parcel of land, being Section 986, Town of Westport, containing by admeasurement 5 acres and 3 perches: bounded on the north by Lyndhurst Street, 500.6 links; on the east by Peel Street, 1002.5 links; on the south by Brougham Street, 500.6 links; on the west by a parcel of land, formerly part of Queen Street, 1002.5 links, to the commencing-point; be the said area and linkages a little more or less.

SECOND SCHEDULE.

BEACH DOMAIN.

ALL that parcel of land, containing by admeasurement 12 acres 1 rood 37 perches, being Section No. 11, Block III, Kawatiri Survey District, also known as Section 1002, Town of Westport: bounded on the north by Section 12, Block III, Kawatiri Survey District, 743.6 and 1286.4 links; on the east by Domett Street, 625 links; on the south by Cobden Street, 1273.2 and 757.3 links; and on the west by Derby Street, 625 links, to the commencing-point: be the said area and linkages a little more or less.

THIRD SCHEDULE.

FORMER PART OF QUEEN STREET.

ALL that parcel of land formerly part of Queen Street, containing by admeasurement 1 acre 1 rood: bounded on the north by Lyndhurst Street, 125 links; on the east by Section 986, 1002.5 links; on the south by Brougham Street, 125 links; on the west by Section 987, 1002.5 links, to the commencing-point: be the said area and linkages a little more or less.
