A BILL INTITULED

AN ACT to amend "The Westport-Ngakawau Railway Extension Title. Act, 1890."

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows :-

1. The Short Title of this Act is "The Westport-Ngakawau short Title. 10 Railway Extension Act Amendment Act, 1897."

2. With respect to the liability which by section six of "The Relief to lease-Westport-Ngakawau Railway Extension Act, 1890," is imposed on holders in respect of the holders in respect of the holders of the therein mentioned coal-mining leases to bear and made good by them. pay the therein mentioned deficiency, the following provisions shall 15 apply :-

(1.) The Governor, if the Westport Harbour Board so requests, may grant to any such holder time, not exceeding two years from the date of the commencement of this Act, for the payment of all moneys owing by such holder in respect of such deficiency up to the passing of this Act, and for that purpose may arrange to accept payment thereof by such instalments and at such periodical intervals as the Governor thinks reasonable.

Struck out.

If such request be made, and if the Governor make arrangements for giving time under this subsection, a return showing the particulars of such arrangements shall be laid before both Houses of Parliament within ten days of the same being made, or if Parliament shall not at the time be in session, then within ten days of the opening of the next session thereof.

(2.) At the like request, the Governor may release any such holder from all liability in respect of any such deficiency arising subsequent to the thirty-first day of March, one thousand eight hundred and ninety-seven, upon being satisfied that such holder has raised sufficient capital to No. 71-4.

If such request be made, and if the Governor shall grant a release under this subsection, a return showing the particulars of the arrangement made as to the raising of sufficient capital as aforesaid shall be laid before both Houses of Parliament within ten days of the same being granted, or if Parliament shall not at the time be in session, then within ten days of the opening of the next 10 session thereof.

3. No relief granted under this Act by the Governor to any such holder shall in any way operate to increase the liability by the aforesaid section six imposed on any other holder.

New clause.

4. Within ten days after any relief has been granted under this Act by the Governor the Colonial Treasurer shall lay before both Houses of Parliament, if in session, or, if not, then within ten days after the commencement of the next-ensuing session thereof, a statement setting forth the nature and extent of the relief so granted, the 20 terms and conditions subject to which it was granted, and, in the case of relief under subsection (2) of section 2 hereof, the particulars of the arrangements made for raising sufficient capital as therein prescribed.

4.5. The aforesaid Act is hereby modified in so far as it conflicts 25 with this Act.
