### A BILL INTITULED

- AN ACT to constitute a Board of Trustees, and to vest in it a certain Public Title. Reserve near to the Town of Waimate, in the Provincial District of Canterbury, for the purpose of a Racecourse.
- WHEREAS the land described in the Schedule hereto has, pursuant to the Preamble. provisions of section one hundred and forty-six of "The Land Act. 1877." been permanently reserved for the purposes of a public racecourse for the Town of Waimate : And whereas it is expedient to vest the same in a Board of Trustees for the purpose of a public racecourse :

BE IT THEREFORE ENACTED by the General Assembly of New Zealand in 10 Parliament assembled, and by the authority of the same, as follows :----

1. The Short Title of this Act is "The Waimate Racecourse Reserve Act, Short Title. 1881."

2. On the passing of this Act, the land described in the Schedule hereto Board of Trustees. shall, without any conveyance, be vested in a Board of Trustees (hereinafter

- 15 called "the Board,") consisting of the following persons: Michael Studholme, John Molloy, and William Jukes Steward, all of Waimate; Michael McGoverin, of the Hook; Pelham Jones, of Waieri; and Andrew Turnbull, of Pareora, all in the County of Waimate.
- 3. The Board shall be a corporate body by the name of "The Trustees of Board incorporated. 20 the Waimate Racecourse," with perpetual succession and a common seal, and with full power and authority by that name to sue and be sued in all Courts whatsover, and shall be capable in law for the purposes and subject to this Act to do and suffer all such acts and things as bodies corporate may do and suffer, with power to take and hold all such lands, tenements, or hereditaments as may 25 be in any manner vested in the Board, either as a site for a racecourse, or for
- any other purpose in connection therewith.

4. If any member of the Board shall be directly or indirectly concerned in any contract with the Board, or shall receive or be entitled to receive any money or emolument for any work done or to be done for the Board, or shall be absent from the colony for the space of twelve consecutive calendar months, or shall be adjudicated a bankrupt or insolvent, or take the benefit of or be brought under  $\mathbf{5}$ the operation of any Act relating to bankrupt or insolvent debtors, or shall become a public defaulter, or shall become convicted of felony, his seat in such Board shall become vacant. 5. It shall be lawful for any member, by writing under his hand addressed to the Governor, to resign his seat upon the Board, and upon the acknowledg- 10 ment of the receipt by the Governor of such writing the seat of such member shall become vacant. 6. If a vacancy occurs in the Board through death, or through any of the reasons aforesaid, it shall be lawful for the Governor to appoint a fit and proper person to fill the vacancy. 15 7. It shall be lawful for the Board to set apart a sufficient portion of the said parcel of land as and for the purposes of a racecourse, and from time to time to vary and alter the portion which may for the time being be so set apart, and to set apart another portion of the said parcel of land as a racecourse in lieu thereof. 208. It shall be lawful for the Roard, by deed under their corporate seal, to lease from time to time, at such rent and on such conditions as they may think reasonable, the whole or any part of the said parcel of land specified in the said Schedule hereto, for any term or terms not exceeding seven years at any one time, and on conditions not inconsistent with the purposes of the racecourse. 25**9**. All moneys received by the Board for the rents, issues, and profits of the said parcel of land shall, after deducting therefrom all necessary expenses incurred in the management thereof, be applied in and towards the cultivation and improvement of the said parcel of land, and in rendering any part thereof that may be set apart as a racecourse suitable for that purpose, and in and 30 towards providing prizes for races to be run on the said racecourse, and generally in and towards the encouragement of the breeding of horses. **10.** The Board shall keep accurate accounts of all sums of money received for rents, issues, and profits on account of the said land, and of all costs, charges. and disbursements in connection with the management and maintenance thereof, 35 and on the thirty-first day of March in every year, or within one week thereafter, the Board shall prepare accounts and a balance-sheet, showing the receipts and disbursements of the Board during the previous year, and the actual financial state of the Board on the thirty-first day of March in that year; and such accounts and balance-sheet shall be forwarded to the Governor. 40 11. It shall be lawful for the Board, and they are hereby authorized and empowered, from time to time to make and alter rules for regulating their own

Bounded Southward by the main branch of the Waimate Creek; Westward by Reserve 1648 (in red), and a line in continuation of the eastern boundary thereof; Northward by the straight portion of the railway reserve, and the prolongation thereof Westward in a straight line, total length 2850 links; and Eastward by a line at right angles to the northern boundary; and numbered 2472 (in red) on the official map in the Survey Office, Christchurch.
