THEREAS doubts exist as to the tolls authorized to be collected Preamble. and taken under the provisions of certain Acts of the Superintendent and Provincial Council of the Province of Wellington, respectively passed in the years one thousand eight hundred and seventy-two and one thousand eight hundred and seventy-three, the first of which is intituled "An Act to amend the Acts of the Superintendent and Provincial Council relating to Toll Gates," and the second of which is intituled "An Act to further amend the Acts of the Superintendent and Provincial Council relating to Toll Gates:"

And whereas it is expedient to put an end to such doubts:

BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows :-

1. The Short Title of this Act shall be "The Wellington Toll Short Title. Gates Act, 1875."

2. Every vehicle having the tires of all its wheels of a breadth of not less than five inches, and so formed that a breadth of not less than five inches comes in contact with the ground on a firm cart road, and every horse drawing such vehicle, shall be chargeable with tolls at one-half the rate which would otherwise be charged thereon under this Schedule.
