Whereas pursuant to section twenty-one of the Schedule to "The Special Powers and Contracts Act, 1881," the Governor leased to the Wellington Harbour Board certain land therein mentioned for the term of forty-two years from the first day of January, one thousand eight hundred and eighty-two: And whereas the Board granted a sub-lease of portion of the said land to the Wellington Meat Export Company (Limited) for the term of twenty-one years from the first day of November, one thousand eight hundred and eighty-two: And whereas the company proposes to expend large sums of money in erecting buildings and machinery on the land comprised in its sublease provided an extended term is secured: And whereas doubts exist whether in granting such sublease the Board was acting strictly within the powers conferred by said section twenty-one: Be it therefore enacted as follows:—
 - (1.) The purposes prescribed by said section twenty-one as those for which the land therein mentioned may be leased are hereby extended so as to include the freezing and storage of meat and of dairy produce:

(2.) The said sublease to the company is hereby validated:

(3.) Subject to the provisions of its lease from the Governor the Board may, subject to the approval of the Governor in Council, arrange with the company to cancel the said sub-lease and execute a new lease to the company for such period (not exceeding the unexpired residue of the term of its lease from the Governor) at such rent and on such conditions as may be agreed on by private contract, anything in "The Harbours Act, 1878," "The Wellington Harbour Board Leasing Act, 1886," or any other Act to the contrary notwithstanding.
