Nothing herein contained shall authorize the making of reserves for the use benefit or endowment of any Municipality outside the limits of such Municipality, nor for any Highway or Road Board outside the limits of such Highway or Road Board: Provided that the total amount of reserves made for the use or benefit or endowment of any Municipality Highway or Road Board shall not exceed five hundred acres in extent.
