The Governor may also alter, amend, or revoke any such Order in Council, in whole or in part.

The Honourable Mr. SHEPHARD, in Committee, to move,-

Clause 1. Add the following paragraph :-

This Act shall come into operation on the *first* day of November next after the passing thereof, except sections two and three, which shall come into operation on such passing.

Clause 17. To omit the first subsection and to substitute the following :-

(1.) In payment, in the first instance, of the general debts and liabilities of the county, as a whole, which are not included in the special appropriations hereinafter mentioned, and of the general expenses incident to the administration of

the said Act, and the several Acts amending the same section (4). To insert after "shall" the following words s In subsection (4). "subject to the provisions of the next following section."

After clause 18 to insert the following :-

18A. With respect to all county roads the following provisions shall have effect :--

- (1.) Every County Council shall, subject to the provisions hereof, have full power to form, construct, improve, repair, and maintain all such county roads and all bridges and ferries therein.
- (2.) The Governor may from time to time order any county road, bridge, or ferry to be made, maintained, or repaired, within such period as he may in any such order determine;

Maintenance of county roads.

and, if the County Council shall refuse or neglect so to make, maintain, or repair any such road, bridge, or ferry, it shall be lawful for the Governor to cause the same to be so made, maintained, or repaired, and the expenses thereof shall be charged against the Corporation so refusing or neglecting as aforesaid, and may be deducted from any moneys payable under the said Act or any other Act of the General Assembly to such Corporation; and in default of any such deduction such expenses may be recovered as a debt due to the Crown from the Corporation.

Clause 20. To add the following paragraph: —

The power granted by this section of levying separate rates shall be in addition to the power granted by section forty-four of "The Counties Act 1876 Amendment Act, 1882," and shall not be controlled by the limit fixed by section forty-five of the last-mentioned Act, but shall be exercised subject to section forty-six of such Act.

After clause 39 to insert the following :---

39A. The word "contract," in subsection four of section sixtytwo of the said Act shall mean, and be deemed to have meant, only a contract executed or made as provided in section one hundred and seventy-two of the said Act.

Clause 40, lines 20 and 21. Omit "and one hundred and eightythree," insert "one hundred and eighty-three and one hundred and eighty-five"; line 25, omit "four"; line 26, omit "twenty-three."
