Provided that the Governor may decline to make such notification, if at any time before that day it is made to appear to him that this Act is objected to by bondholders representing not less than one-

third in value of all the bonds.

4B. No person or body whomsoever shall have any claim against the Crown or the revenues of the Crown by reason of anything contained in this Act.
