INDUSTRIAL CONCILIATION AND ARBITRATION AMENDMENT BILL.

Hon. Mr. Rigg, in Committee, to move the following amendments:

Clause 3: In line 2, strike out the words "number of," and insert in lieu thereof the words "two or more." In line 3, strike out the words "or of different employers." In line 10, strike out "their" and insert "the," and strike out "employers or" and insert "employer." In line 11, strike out "any of them," and insert after the word "terms" the words "and conditions." In line 18, after the word "terms," insert "and conditions."

Clause 4: In line 3, after the word "dismissing," insert "or suspending"; in the same line, after the word "any," insert "two or more." In line 4, after the word "dismissal," insert "or suspension"; in the same line, strike out the word "worker" and insert "workers." In line 5, after the word "dismissed," insert "or suspended." In line 7, strike out "any" and insert "such." In line 8, after the word "terms," insert "and conditions." In line 13, after the word "terms," insert "and conditions."

To add to clause 5 the following new subclause:

(2.) In this Act the expression "to lock out" means to become

a party to a lock-out.

Clause 5: In line 4, after the word "liable," insert "for any breach of the provisions of such award or industrial agreement." Add to subclause (1) the following proviso:

Provided that the aggregate amount of such penalties shall not

exceed five hundred pounds.

Clause 9: In line 4, strike out the words "the striker" and insert "such person." In line 5, strike out the words "on summary conviction before a Magistrate"; and in the same line strike out the word "fine" and insert "penalty." Subsection 2, line 5: Strike out the words "on summary conviction before a Magistrate." In line 6, strike out word "fine" summary conviction before a Magistrate." In line 6, strike out word "line" and insert "penalty." Strike out paragraphs (e), (f), and (g). Subclause (4), lines 4 and 5: Strike out the words "on summary conviction before a Magistrate"; and strike out the word "fine" and insert "penalty." Subclause (5): In line 2, strike out the word "or"; in line 3, strike out "conviction"; in line 4, after the word "sections," insert "or under this section"; in line 5, strike out "under any other of those sections."

Clause 10: In line 1, after the word "when," insert "a judgment has been obtained against"; in line 2, strike out the words "is convicted"; in the same line, strike out the word "of" after word "Act," and insert "for." Subclause (5) line 3: Strike out "or conviction." Subclause (7): In line 1,

Subclause (5), line 3: Strike out "or conviction." Subclause (7): In line 1, strike out "or conviction"; in line 4, strike out words "or of the fines imposed by that conviction."

Clause 14, line 1: Strike out the word "such," and insert after the word "penalty" the words "imposed in accordance the provisions of the

last preceding section."

Clause 17: In line 1, after the word "recovered," insert "by an Inspector of Awards"; in lines 2 and 3, strike out the words "recovered by the plaintiff to the use of the Crown, and the amount thereof shall, when received by the plaintiff." Subclause (2), line 2: After word "Court" insert "to the use of the plaintiff"; and strike out the remainder of the subclause.

Clause 19: At end of subclause (1), insert the words "whatever be the

amount of that judgment."

Clause 20: In the second proviso, line 2, strike out the words "or wages which may at any time thereafter become due"; and in lines 3 and 4 strike out the words "although they are not yet earned or owing."

Clause 27, subclause (2): In line 3, strike out the word "or" and insert

"and."

Clause 28: In line 2, strike out "not exceeding four in number."

Clause 54: Omit the clause.

Clause 58: In line 2, strike out "or otherwise by law"; and in same line strike out "in" and insert "such." In line 6, after the word "which," insert "such worker ceased to be employed by the said employer"; and strike out the remainder of the clause.

Clause 68, line 2: After the word "Court" strike out "may, if it considers that for any reason an award ought not to be made in the matter

of that dispute, refuse to," and insert "shall."
