### ORDER OF THE DAY.

1. Inspection of Machinery Bill—to be committed.

#### *Contingent Notice of Motion.*

The Honourable Dr. POLLEN, in Committee on the Inspection of Machinery Bill, to move the following amendments :—

In clause 12, lines 3 and 4, to omit “ a person under the age of eighteen years and of the male sex,” and insert “ any person unless he is a male of at least eighteen years of age.”

In clause 15, line 11, before “ machinery ” to insert “ several parts of.”

In clause 18, lines 24 and 25, to omit “ part of a machine,” and insert “ machinery ” in lieu thereof.

In the preamble to Part IV., in line 9, after “ Act,” to insert “ and all other the provisions of the preceding Parts of this Act.”

In line 10, after “ applicable,” to insert “ and may be enforced.”

To add to clause 31,—

“ All boilers shall be inspected at least once in every year, or oftener as occasion shall require: Provided that the fee for inspection of a boiler shall be payable in respect of such annual inspection, and not oftener for the same boiler.

Whenever any machinery shall have been once inspected under this Act, and a certificate of such inspection shall have been given as hereinafter provided, no further fee shall be payable for any subsequent inspection of the same machinery.”

In clause 37, line 4, after “ power or control,” to insert “ And for the purposes of this section the words ‘ immediate power or control ’ shall mean where any machinery or a boiler is worked or used by the owner of such machinery personally, or his agents servants or others under his orders or directions, and for his benefit or profit.”
