

# Supplementary Order Paper.

## LEGISLATIVE COUNCIL.

Friday, the 12th Day of December, 1913.

NATIVE LAND CLAIMS ADJUSTMENT BILL.

Hon. Mr. BELL, in Committee, to move the following new clauses:—

Assessment of ground rent of Native reserves. A. In every case where a new assessment of ground rent has to be made under paragraph two of section fifteen of the Native Reserves Act, 1882, it shall be made by arbitration.

Public Trustee declared a leasing authority with respect to Palmerston North Native Reserve. B. (1.) With respect to the Native reserve, containing seventy-one acres and one rood, or thereabouts, being the land hereinafter described, situate in the Borough of Palmerston North, and vested in the Public Trustee, the Public Trustee shall be deemed to be a leasing authority within the meaning of the Public Bodies' Leases Act, 1908, and may lease the same or any part thereof in accordance with the provisions of that Act.

(2.) Section twelve of the said Act shall apply to now-existing leases granted by the Public Trustee of land comprised in the said reserve.

(3.) The powers conferred upon the Public Trustee by this section are irrespective of all other leasing-powers exercisable by him under the Native Reserves Act, 1882, or any other Act.

(4.) The land to which this section relates is the Native reserve in the Borough of Palmerston North, comprising Sections Nos. 203, 204, 205, 207, 209, 210, 211, 212, 213, 214, 218, 219, 220, 228, 237, 238, 239, and 276 in the said borough.

WHAKARITERITE KEREME WHENUA MAORI.

Honore Te PERE, i roto i te Komiti, ka motini i enei rarangi hou e whai ake nei:—

A. I ia keehi e whakahaungia ana kia whakatauria houtia ai tetahi whakataunga i te moni reti mo te whenua i raro i rarangi rua o tekiona tekau ma rima o te Ture Rahui Maori, 1882, me whakatau i runga i te tikanga apitireihana.

B. (1.) Mo runga mo te Rahui Maori, tona rahi e whitu tekau ma tahī eka kotahi ruuri, nuku atu iti iho ranei, ara mo te whenua a muri ake nei whakaaturia ai, kei roto kei te Paro o Pamutana Nota, kua oti nei te whakataka ki raro ki te Kai-tiaki o te Katoa, ka kiia hoki te Kai-tiaki o te Katoa he mana tuku riihi i raro i te aronga o te Public Bodies' Leases Act, 1908, a me ahei ia te riihi i taua whenua i tetahi wahi ranei o taua whenua i raro i nga tikanga o taua Ture.

(2.) Me pa a tekiona tekau ma rua o taua Ture ki nga riihi e haere nei i naianei i whakaputaina e te Kai-tiaki o te Katoa o te whenua kei roto nei i taua rahui.

(3.) Ko nga mana kua whakawhiwhia atu ki te Kai-tiaki o te Katoa e tenei tekiona kei waho ke atu i nga mana riihi e taea ana e ia te whakahaere i raro i te Ture Rahui Maori, 1882, i tetahi atu Ture ranei.

(4.) Ko te whenua e pa atu ana mo reira tenei tekiona ko te rahui Maori kei roto kei te Paro o Pamutana Nota, ara ko Tekiona Nama 203, 204, 205, 207, 209, 210, 211, 212, 213, 214, 218, 219, 220, 228, 237, 238, 239, me 276 i roto i taua Paro.
