NOTICES OF MOTION.

1. The Honourable Mr. BUCKLEY to move, That a Select Committee be appointed to inquire into the circumstances connected with the non-payment or arrears of rent of the Wakatipu Runs; with power to call for persons and papers, and to report in a fortnight. Contingent Notice of Motion.

The Honourable Sir D. BELL, when in Committee on the Port Chalmers Waterworks Act Amendment Bill, to move the following amendments:—

In section 2, line 6. To omit the words "Municipal Corporations Waterworks Act, 1872," for the purpose of inserting the words, "the provisions of "The Municipal Corporations Act, 1876," relating to waterworks constructed under that Act."

In section 5, line 3. To omit the words "Waterworks Act, 1872," for the purpose of inserting the words "Act, 1876, relating to waterworks."
